

Dear Sir,

I do hereby lodge complaint empowered by enacting The Electricity Act-2003,  
subsequently Electricity (Amendment) Act-2007 to the effect that Bhagirath Kumar  
Sl.O - Narayan Kumar was using electricity dishonestly  
the hooking from nearest L.T.O.H line and due to this reason  
has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).

On 15/02/2023 at 2:00 P.M. I Biswanath Barui AE (S&L-P)  
alongwith:

- Entered the premises of Bhagirath Kumar, Sl.O - Lt. Narayan Kumar

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she  
was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of  
W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments

- 1) CFL 3 nos 5 watt each = 27 watt
- 2) Fan 2 nos 80 watt each = 160 watt
- 3) Bulb 1 no 60 watt = 60 watt
- 4) Total = 247 watt
