I do hereby lodge complaint empowered by enabling The Electricity Act-2003,

from nearest L.T.O.H line and due to this reason

Entered the premises of Paltu Kumar Sl.no - Bhagtu Kumar

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she  
was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of  
W.B.S.E.D.C.L i.e. U/S 135(I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments

- 2) Fan 2 nos. 80 watt each = 160 watt
