I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act-2007 to the effect that Jay Prakash Kumar, S/o Late Govind Kumar, Vill- Chhatihansra P.S. Arsha has committed theft of electricity U/s 135 (1/b) of the electricity (Amendment act-2007) on 15/12/2023 at 3:00 PM.

Entered the premises of Jay Prakash Kumar, Vill- Chhatihansra, PS. Arsha, Dist- Purulia, having Consumer No: 2412409888 Meter No: P.2232425 and inspected his/her premises.

During inspection theft of electricity was detected i.e bypassing of the energy meter U/s 135(1/b) was detected. The details of bypassing arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house/commercial premises. Jay Prakash Kumar, without energy registration in WBSEDC energy meter.

From the above by-passing system he/she uses the following electrical equipments:

- 1) Lamp - 4 X 9 W = 36 Watt
 - 2) Pump - 1 X 3.50 = 3.50 Watt
 - 3) Fan - 4 X 8.0 W = 32.0 Watt
- Total - 70.6 Watt

Out of which I seized the following:

One Energy meter scale no. P.2232425 with tamper proof box, by bypassing arrangement from main Phase.

Seizure list was prepared at the site and accused person refuse to sign/Signed. The inspection team left the premises at 3:20 pm. on 15/12/2023.

The accused person has committed an offence U/s 135(1/b) of the electricity act-2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint & treat it as F.I.R and action may be taken as per rule.
