I, SI Sk. Afiruddin, O/C, Arsha PS do hereby lodge this FIR as sou-moto against driver namely Bikash Rajwar (26Y) S/O-Ashari Rajwar of Sirkabad, PS- Arsha, Dist- Purulia and owner of seized tractor having Reg. no. WB55B/6091 along with trolley (sand approx 60 CFT). Today on 15.02.2023 at about 20.05 hrs. during my evening mobile duty myself along with (i) C/- 853 Kiran Ch. Murmu and (iii) C/-694 Nekibuddin Khan both of Arsha PS vide C.C No. 433/23 Dtd. 15.02.2023, after getting the information, I reached at Bandu River Ghat near Ahrrah morh under Arsha PS at 20.25 hrs and we conducted raid at Bandu Ghat on the Bank of Bandu river near Aharra morh under Arsha PS and found that 01 (one) tractor along with trolley loaded with sand was present at Bandu Ghat on the Bank of River Kansai. Seeing the Police party the driver namely Bikash Rajwar (26Y) S/O-Ashari Rajwar of Sirkabad, PS- Arsha, Dist- Purulia of said tractor tried to flee away, but I apprehended him. I asked him to produce valid documents in support of carrying sand, but he could not produce as such documents. Hence I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver Bikash Rajwar (26Y) S/O-Ashari Rajwar of Sirkabad, PS- Arsha, Dist- Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer. Hence I do record Arsha PS Case No 19/23 dated 15.02.2023 U/S- 379/411/414/120B IPC & 21 (1) (4) of Mines and Minerals (R&D) Act-1957 as sou-moto against driver named Bikash Rajwar (26Y) S/O-Ashari Rajwar of Sirkabad, PS- Arsha, Dist- Purulia and the driver of the said tractor.
