**Sub:** Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused persons namely 1. Tushar Rewani (20) s/o Madhusudan Rewani, 2. Kanchan Mandal (37) s/o Krista Mandal both of vill Kantadih, PS Arsha, Dist.- Purulia, along with Memos of arrest, seizure list & seized articles i.e 08 (eight) pcs iron angels (length approx 04 feet-04, 09 feet-02, 12 feet-01, 17 feet -01)

I beg to submit that today on 24.02.2023, myself along with C/238 Dipak Bagti and C/222 Pravash Ch. Mandal left P.S to perform evening mobile duty at Kantadih side area under Arsha P.S vide Arsha P.S CC No.522 dtd. 24.02.2023. During mobile duty when we reached at Kantadih near Mandal Hotel over Purulia-Tata road (NH-32) at about 20.45 hrs. found that 02 persons is carrying the iron angels beside Kantadih-Purulia pitch road near Mandal Hotel. Seeing the Police party they tried to flee away. Somehow we managed to apprehend above noted 02 (two) alleged persons and on being asked their identity, they disclosed their identity as 1. Tushar Rewani (20) s/o Madhusudan Rewani, 2. Kanchan Mandal (37) s/o Krista Mandal both of vill Kantadih, PS Arsha, Dist.- Purulia. I asked them to produce valid paper/challan in respect of iron angels but they failed to produce any papers or challan and cannot gives any satisfactory answer about carrying iron angels. As there is every reason to believe that they were carrying the above noted iron angels and illegally.

Accordingly, I seized 08 (eight) pcs iron angels (length approx 04 feet-04, 09 feet-02, 12 feet-01, 17 feet -01). The seizure list was prepared at P.O and duly signed by detained persons and witnesses. After that I arrested them by issuing memos of arrest. Then myself along with force and accused persons left for PS with seized articles.

On arrival at PS I prepared this letter of complaint and handed over everything to O/C Arsha through Duty officer for starting a case under proper section of law against the accused persons.
