Sir,

In producing herewith 01 (One) arrested accused person namely Nibaran Mahato (22 Yrs), S/O- Barun Mahato of Vill- Atna, PS- Baghmundi, Dist-Purulia along with one seized new Blue Coloured Sonalika DI-35 Tractor without Registration number bearing Engine No- 3100FL73F650459F3, Chassis No- HZJST656348SM along with trolley loaded with sand under proper seizure list, I beg to submit that today (14.02.2023) I along with (1) C/1355 Rajib banerjee, (2) C/2869 Durbadal Sannigrihi, (3) NVF/810 Sakru Mahato all of Suisa OP under Baghmundi P.S were performing night Mobile duty vide Suisa OP CC No- 230/2023, dtd- 14.02.2023 & GDE No- 388, dtd-14.02.2023. During my mobile duty at about 21:25 hrs I along with force reached near Jordih village on Atna-Dugdha Xing Muram road under Baghmundi PS and found that the above noted tractor along with trolley loaded with sand was coming from Atna village side. On seeing the Police party near Jordih village, the driver of the said tractor was trying to flee away. But after a hot chase, we could able to detain the driver of the said tractor. I asked the said driver to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admitted that he is dealing with illegal sand lifting from Subarna-Rekha river bed. The owner of the said tractor was also involved in this illegal lifting and transportation. Hence, I seized the new Blue Coloured Sonalika DI-35 Tractor without Registration number bearing Engine No- 3100FL73F650459F3, Chassis No- HZJST656348SM along with trolley loaded with sand in between 21:45 hrs to 21:55 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Nibaran Mahato (22 Yrs), S/O- Barun Mahato of Vill- Atna, PS- Baghmundi, Dist-Purulia at 22:05 hrs and issued check list. I brought the said sand loaded tractor to Baghmundi P.S. Compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive dealing with sand illegally without any valid document.

Therefore, I pray before you that a case against the driver namely Nibaran Mahato (22 Yrs), S/O- Barun Mahato of Vill- Atna, PS- Baghmundi, Dist-Purulia and the owner of the Blue Coloured Sonalika DI-35 Tractor without Registration number bearing Engine No- 3100FL73F650459F3, Chassis No- HZJST656348SM may kindly be started and arrange for its investigation.
