Sir,

In producing herewith the arrested accused person namely Sharukh Ansari (27 yrs) S/O- Islam Ansari of Balarampur Registry para, P.S- Balarampur, Dist.-Purulia with seized items approx 26 MT (twenty six) Coal, I beg to submit that on 05.02.2023 in course of my mobile duty at P.S area, received a credible source information at about 19:15 hrs that some persons heaped steam coal by receiving illegally at Berma morh area, near Berma bypass beside the Purulia – Tata main road (NH-32). After brought to notice of my superiors and as per their direction, I along with force left for P.O to workout the source information. After proceeding towards the P.O at about 19:35 hrs & we reached at Berma morh area, near Berma bypass beside the Purulia – Tata main road (NH-32) as per source information & we found the aforesaid person as well as heap of steam coal (approx 26 MT). On being interrogation the aforesaid person could not produce any valid documents in respect of heap of steam coal approx (26 MT). On being interrogation he confessed that he stored up the said coal after receiving dishonestly having knowledge as stolen property for aiming to deal for profit also stated that he is working under one Hamid Ansari S/O- not known of Balarampur Registry Para (Jola Para), P.S- Balarampur, Dist.-Purulia who was completely involved to running this business for aiming to deal for profit. After that I arrested the aforesaid accused person namely Sharukh Ansari (27 yrs) S/O- Islam Ansari of Balarampur Registry para, P.S- Balarampur, Dist.-Purulia after maintaining all formalities regarding the arrest.

However we conducted search of the Scene of Crime & searched the surrounding the area and seized the following articles as:

(1). Approx 26 MT (twenty six) Steam coal which was stored up as stolen property for aiming to deal for profit. [Seized as Stolen Recovered Articles and the copy of seizure list attached here with]

I seized the above articles as stolen recovered property in between 20:05 hrs to 21:45 hrs in presence of Police witnesses and others. I have arranged to bring those seized articles to PS compound. I have also tried to find out the local witnesses but found none since usually none other.

I therefore pray before you to lodge a specific case against accused namely 1). Sharukh Ansari (27 yrs) S/O- Islam Ansari of Balarampur Registry para, P.S- Balarampur, Dist.-Purulia & 2). Hamid Ansari S/O- not known of Balarampur Registry Para (Jola Para), P.S- Balarampur, Dist.-Purulia under proper section of law.
