I Sri Sisir Kumar Das, S/O- Banamali Das, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sri Pitar Besra, S/o. Lt. Guhiram Besra resides at Nandudi, P.O:- Namsole, PS: Balarampur, Dist. Purulia to the effect that received an information, that the aforesaid accused person was committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information on 09.02.2023 from 1.35 PM to 2.10 PM I, along with Sri Manab Kr. Maji, J.E. Gr-II, Sri Arindam Chatterjee, Sr. O.E., Balarampur CCC and technical persons of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) inspected the premises of Sri_Pitar Besra and held raid.

During raid and inspection it was detected that accused Sri_Pitar Besra was using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1 No. 200 watt bulb, 1 No 100 watt bulb, 1 No. Ceiling Fan having connected load 0.4 KW.

I prepared Inspection report in presence of the Accused and assessed the Load as 0.4 Kw. Details have been mentioned in the Inspection Report duly signed by the representative of the accused.

I directed Sri Sourav Banerjee, Supervisor of M/S Niharika Electric Works to disconnect the hooking line/arrangement from our LTOH line. Accordingly he disconnected the aforesaid hooking line/arrangement from LTOH Line.

I prepared seizure list in presence of the accused & witnesses, details of seizure have been mentioned in the seizure list duly signed by the representative of the accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
