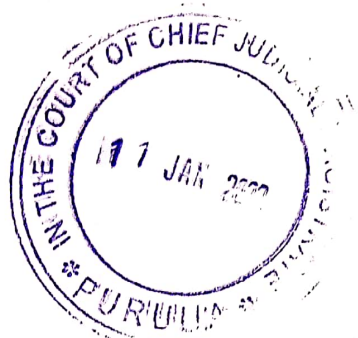

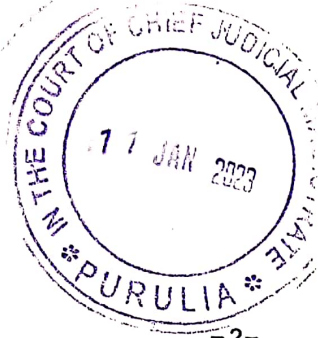

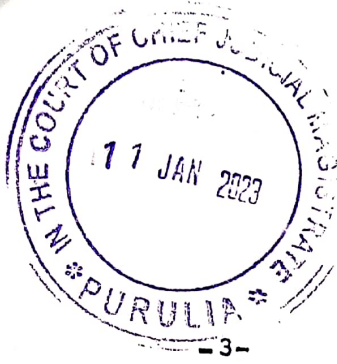

1...That the complainant is an old aged person having right,

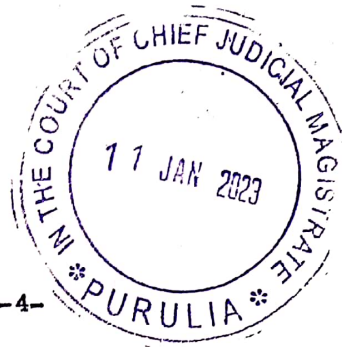
2...That previously Kashinath Mahato father of the Complainant used to cultivate the said land by growing and harvesting paddy .

3...That after the death of Kashinath Mahato the complainant and his younger brother are cultivating over the disputed land by growing and harvesting paddy.

4...That recently on 17.12.2022.in the morning the above-named accused persons namely 1. Man Sing Sardar 2. Gunudhar Sing Sardar 3. Dhananjoy Sing Sardar 4. Manindra Sing Sardar 5. Nayan Sing Sardar 6. Durjodhan Sing Sardar. 7. Shankar Sing Sardar 8. Bhura Sing Sardar 9. Shantiram Sing Sardar 10. Akali Sing Sardar 11. Rabi Sing Sardar 12. Laltu @ Latu Sing Sardar 13. At that time the above-named accused persons uses filthy languages and threatened your petitioner with diree consequences and assaulted him by fists ,blows and with lathi, and as a result of which he sustained on injury on his parts .

They have committed mischeif after having made preparation e for causing hurt and wrongfully restrained him on fear of death . They have entered into the possess- ion of land of your petitioner with intend to committ an offence or to intimidate ,insult and/or annoy to the possession of land of your petitioner and they have unlawfully enter into the land of your petitioner . They have also committed of grievous hurt to the petitioner., and they have ~~px~~ causes destruction of the landed proper- ty of the complainant by entering into the land and by cutting the paddy plants of the complainant. There is criminal intimidation at the instance of the above-named accused persons. They have also committed offence of theft by taking away the growing and rippen paddy plants. through their Tfactor and thesaby they have stolen paddy plants which amounts to Rs.40,000/- (Rupees Forty thousand).

6...That the ,matter was reported and informed to the Officer-in-Charge of Bandwan Police Station for taking necessary action but till today no acton has been taken by the police against the above-named accused persons.
