
In producing herewith one PC accd namely Niranjana Murmu @ Tala (29 Yrs), S/O- Lt Satish Murmu, Vill- Makopali, PS- Bandwan, Dist- Purulia in C/W Bandwan PS Case No-03/23, Dtd-13/01/23, U/S-326/307/120B I.P.C & 25/27/35 Arms Act 1959 brought under seizure one improvised fire arms length approx 23.5 cm having butt 6.5 cm, body 10 cm, barrel 14 cm, firing pin and one 8 M.M KF live cartridge etc. under proper seizure list duly signed by the witnesses as well as PC accd and do hereby lodge a complaint against PC accd Niranjana Murmu @ Tala (29 Yrs), S/O- Lt Satish Murmu, Vill- Makopali, PS- Bandwan, Dist- Purulia to the effect that today i.e. on 03/02/23 at about 17:05 hrs, during interrogation he confessed that he has an improvised firearms in a secret place in his house at Makopali and he will produce the same to Police if he get a chance. Accordingly I informed my OC and diarized the matter in GD (vide Bandwan PS GDE No. 135/22, Dtd-03/02/23). After getting permission to work out the information leading to confessional statement of Accd Niranjana Murmu @ Tala (29 Yrs), S/O- Lt Satish Murmu, Vill- Makopali, PS- Bandwan, Dist- Purulia during his PC period in connection with Bandwan PS Case No-03/23, Dtd-13/01/23, U/S-326/307/120B I.P.C & 25/27/35 Arms Act 1959 myself along with force left P.S. Having reached at the house of the PC accd Niranjana Murmu @ Tala I call some disinterested person from the village Makopali. But only two persons namely 1. Gyanranjan Hansda (37 yrs) S/O-Chunaram Hansda 2. Khagen Tudu (58 yrs) S/O-Lt. Baidyanath Tudu both of Vill- Makopali, PS-Bandwan, Dist-Purulia appear beside those no one come to the spot as witness due to fear of the PC accd Niranjana Murmu @ Tala. After that prior to take entry in the house of the PC accd Niranjana Murmu @ Tala I offered the witnesses to search ourselves. After searching ourselves and our vehicle they don't found anything. Accordingly I made a "Nil" seizure list in presence of the witnesses and duly signed by them. After taking entry we search the house thoroughly with the help of torch light and PC accd Niranjana Murmu @ Tala brought and produced one improvised firearm and one 8 M.M KF live cartridge (details are in seizure list) which he kept in a plastic bag and kept conceal in a secret manner in his trunk. So, I seized that firearms duly signed by the witnesses as well as PC accd Niranjana Murmu @ Tala and my accompanying forces and also labeled the same.

Therefore, I pray, that a specific case may kindly be started against the PC accd Niranjana Murmu @ Tala (29 Yrs), S/O- Lt Satish Murmu, Vill- Makopali, PS- Bandwan, Dist- Purulia under 25 Arms Act and for arranging its investigation.
