I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007 to the effect that Bidhan Kumbhakar S/O Late Gotilal Kumbhakar of Vill- Manpur, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally by hooking from nearest LT OH line with the help Two core Flexible Cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 09.02.2023, I Sri Banti Karmakar, A.E.&S.M., BARABAZAR CCC, WBSEDCL along with

- (1) Shibaji Chakraborty, J.E GR II, BARABAZAR CCC, WBSEDCL.
- (2) Suresh Sao, O.E., Barabazar CCC, WBSEDCL

At About 05:00 P.M., entered into the premises of Bidhan Kumbhakar S/O Late Gotilal Kumbhakar of Vill- Manpur, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill- Manpur, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Bidhan Kumbhakar S/O Late Gotilal Kumbhakar of Vill- Manpur, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of Two core Flexible Cable in his premises at Manpur having connected load 0.165 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts)
02. 01 no Fan (60 watts)
03. 01 no of Two core Flexible Cable (10 Mtrs. App.) along with hooking device

Out of which I seized the following articles:

01. 01 no of two core Flexible Cable (09 Mtrs. App.) along with hooking device
