I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that SASADHAR SINGH LAYA S/O Lt MARIRAM SINGH LAYA Vill- BANKADIH, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- 354449) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 23.02.2023, I Sri SHIBAJI CHAKRABORTY, J.E. Gr-ii, BARABAZAR CCC, WBSEDCL along with

- (1) MD QASIM ANSARI, Sr.O.E, BARABAZAR CCC, WBSEDCL
- (2) MANDEEP CHAKLADAR, O.E., BARABAZAR CCC, WBSEDCL

At About 04:05 P.M., entered into the premises of SASADHAR SINGH LAYA S/O Lt MARIRAM SINGH LAYA Vill- BANKADIH, Dist- Purulia and inspected his premises at Vill.- BANKADIH, P.S Barabazar, DIST- Purulia.

During inspection, it was found that SASADHAR SINGH LAYA S/O Lt MARIRAM SINGH LAYA Vill- BANKADIH, P.S- Barabazar, Dist.- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- 354449) From its incoming Service Cable through 02-Core PVC wire in his premises at BABUIJHOR having connected load 0.07 KVA.

From the above he was using the following arrangements:
