Sub: Complaint against Khitish Sahis (30 Yrs) S/o- Subhas Sahis of Vill- Natundih, PO- Nischintapur, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing herewith the arrested accused person namely Khitish Sahis (30 Yrs) S/o- Subhas Sahis of Vill- Natundih, PO- Nischintapur, PS- Barabazar, Dist-Purulia and seized one plastic Jerakin containing approx 10 (Ten) Litters I.D liquor (Cholai) on which 500 ml seized as sample from the mother contraband as sample as per enclosed seizure list.

I, ASI Manas Kumar Pan of Barabazar PS do here by lodge this complaint against one Khitish Sahis (30 Yrs) S/o- Subhas Sahis of Vill- Natundih, PO-Nischintapur, PS- Barabazar, Dist- Purulia. I beg to state that today i.e. on 26.02.2023 myself along with C/- 897 Umapada Dhalla & C/- 111 Samulal Tudu were left for evening mobile duty vide Barabazar PS GDE No- 1511 Dtd. 26.02.2023. During mobile duty at about 17.25 hrs I received information that one person was selling I.D liquor in his shed house near Natundih village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said area to work out the information. At about 18.05 hrs as per source information myself along with force held a raid in the shed house of Khitish Sahis and found that he was keeping & selling I.D Liquor (Cholai) from his said house. Seeing the Police party buyers fled away, but we apprehended the seller who kept & selling I.D Liquor (Cholai). On search I found one plastic Jerakin containing approx 10 (Ten) Litters I.D liquor (Cholai). On demand, he failed to produce any valid documents / License in respect of keeping & selling I.D liquors (Cholai). On being asked he confessed his guilt and stated that he was selling the I.D liquors (Cholai) to the local people with intent to make his own profit. He disclosed his identity as Khitish Sahis (30 Yrs) S/o- Subhas Sahis of Vill- Natundih, PO- Nischintapur, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of I.D liquors (Cholai). Accordingly, I seized above noted I.D Liquor (Cholai) after preparing proper seizure list and put label on the seized articles in presence of the witnesses and on which 500 ml of I.D liquor taken as sample from the mother contraband which were also duly labeled by me and also took signature of the accompanying forces as witness on seizure list and label as well as accused person also. I try to find local witnesses but no one turns up before me. The seizure and label was done in between 18.25 hrs and 18.45 hrs.

Thereafter, I arrested the accused person namely Khitish Sahis (30 Yrs) S/o-Subhas Sahis of Vill- Natundih, PO- Nischintapur, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the grounds of arrest. The arrest was made on 26.02.2023 at 18.45 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Khitish Sahis (30 Yrs) S/o- Subhas Sahis of Vill- Natundih, PO- Nischintapur, PS- Barabazar, Dist- Purulia under proper section of Law.
