Sub: Complaint against (i) Lalmohan Mahato (Male/ 28 Yrs.) S/O- Bankabihari Mahato and (ii) Narayan Mahato (Male/ 28 Yrs.) S/o- Lt. Anil Mahato both of Village- Palasdih, P.O-Madhavpur, PS- Boram, Dist- East Singbhum (JKD) to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused persons namely (i) Lalmohan Mahato (Male/ 28 Yrs.) S/O- Bankabihari Mahato and (ii) Narayan Mahato (Male/ 28 Yrs.) S/o- Lt. Anil Mahato both of Village- Palasdih, P.O-Madhavpur, PS- Boram, Dist- East Singbhum (JKD) and seized Two Plastic Jarakin (i) One is Containing approx 08 (Eight) liters and (ii) Approx 07 (Seven) Ltrs. I.D liquors (Cholai) on which ½ Ltr. from each Jarakin taken as sample as per enclosed seizure list.

I, PSI Alope Rana of Barabazar PS do here by lodge this complaint against one (i) Lalmohan Mahato (Male/ 28 Yrs.) S/O- Bankabihari Mahato and (ii) Narayan Mahato (Male/ 28 Yrs.) S/o- Lt. Anil Mahato both of Village- Palasdih, P.O-Madhavpur, PS- Boram, Dist- East Singbhum (JKD). I beg to state that on 11.02.2023 myself along with C/- 677 Syed Julhar Ali & C/- 1187 Samar Kanta Maity were left for spl. mobile duty vide Barabazar PS GDE No- 634 Dtd. 11.02.2023. During mobile duty at about 18.05 hrs I received information that two persons was carrying I.D liquor and going towards Kukurchari morh. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 18.35 hrs I detained two persons at Kukurchari morh under Barabazar PS who were carrying Jarakin. Seeing the Police party the alleged persons tried to flee away, but I apprehended them with the help of the Police party and on being searched I found that the persons carrying two jarakin (i) One is Containing approx 08 (Eight) liters and (ii) Approx 07 (Seven) Ltrs. I.D liquors (Cholai). On demand, they failed to produce any valid documents / License in respect of carrying/selling I.D liquors (Cholai). On being asked they confessed their guilt and stated that they carried the I.D liquors (Cholai) with intent to sell to make their own profit. They disclosed their identity as (i) Lalmohan Mahato (Male/ 28 Yrs.) S/O- Bankabihari Mahato and (ii) Narayan Mahato (Male/ 28 Yrs.) S/o- Lt. Anil Mahato both of Village- Palasdih, P.O-Madhavpur, PS- Boram, Dist- East Singbhum (JKD). They also admitted that they have no license or any authorization for carrying/selling of I.D liquors (Cholai). Accordingly, I seized Two Plastic Jarakin (i) One is Containing approx 08 (Eight) liters and (ii) Approx 07 (Seven) Ltrs. I.D liquors (Cholai) after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which ½ Ltr. from each Jarakin taken as sample which were also duly labeled by me and also took signature of the accompanying witness on seizer list and label as well as accused persons also. The seizure and label was done in between 18.45 hrs and 18.55 hrs. Thereafter, I arrested the accused persons namely (i) Lalmohan Mahato (Male/ 28 Yrs.) S/O- Bankabihari Mahato and (ii) Narayan Mahato (Male/ 28 Yrs.) S/o- Lt. Anil Mahato both of Village- Palasdih, P.O-Madhavpur, PS- Boram, Dist- East Singbhum (JKD) after preparing Memo of Arrest & after observing all other formalities regarding their arrest as per Cr.PC and NHRC guideline. Accordingly, informed them and their relatives regarding the ground of their arrest over mobile. The arrest was made on 11.02.2022 at 18.55 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused persons namely (i) Lalmohan Mahato (Male/ 28 Yrs.) S/O- Bankabihari Mahato and (ii) Narayan Mahato (Male/ 28 Yrs.) S/o- Lt. Anil Mahato both of Village- Palasdih, P.O-Madhavpur, PS- Boram, Dist- East Singbhum (JKD) under proper section of Law.
