
In producing herewith arrested accused driver Mobarak Ansary (20) S/O-Sekandar Ansary Of Vill-Bishpuria, PS-Hura, Dist-Purulia driver of Vehicle No. WB37D/8340 along with one seized White Colour Pick up Van bearing Registration No. WB37D/8340 loaded with straw in unsafe condition, I beg to submit that I, SI Bablu Ghosh of Hura PS along with C/1450 Uttam Mahapatra, C/877 Basudev Mahato and NVF/68 Mahanta Mahato all of Hura PS were performing anti-crime evening mobile duty on Bankura-Purulia road at Lodhurka side under Hura PS vide Hura PS CC No- 301/23 Dtd- 01.02.2023 & Hura PS GDE No. 38 Dtd- 01.02.2023 at about 18:45 hrs. while we reached at Ladhurka More under Hura PS, Dist- Purulia, we found that one White Colour Pick up Van bearing Registration No. WB37D/8340 loaded with straw as unsafe condition was coming from Kashipur side and going towards Purulia side rashly and negligently and also unsafe condition loaded with straw. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop the said vehicle at Ladhurka near Reliance Petrol Pump on Purulia - Bankura Pitch Road (NH 60A) under Hura PS, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. Being asked to produce all relevant documents in respect of said vehicle but he failed to produce any original documents in respect of said vehicle. Accordingly I seized the White Colour Pick up Van bearing Registration No. WB37D/8340 loaded with straw in unsafe condition in presence of witnesses and I also arrested the above noted accused driver under proper memo of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC read with section 184/190 of MV Act and informed him and his relatives regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the above noted arrested accused driver namely Mobarak Ansary (20) S/O-Sekandar Ansary Of Vill+PO-Bishpuria, PS-Hura, Dist-Purulia u/s 279 IPC read with section 184/190 of MV Act and arrange its investigation.


