illegal mining activities at Kudlung A sand mining block under

Sir,

This is to inform you that the office of the undersigned have conducted a joint raid along with the officials of your office on 10/02/2023 near kansai river at Kudlung. During raid it is observed that one orange coloured Tata Hitachi Ex 200 Lci Pokhland machine was extracting and loading sand from the lease hold sand mining area of Kudlung- A ghat over Kansai river under hura block. The lease of the said sand block has been setteled in favour of Ambey Niwas Pvt Ltd. Three persons namely Hemanta Paitundi S/O- Monbodh Paitundi, Rabindranath Bauri S/O- Manik Bauri of Kashipur and Joydeb Bauri S/o- Durgapada Bauri were present during the raid and they claimed themselves as supervisors of the said lease owner. They also informed us that the owner of the Pokhland is one Sanjoy Modak. As the place of occurrence was the border line between Hura P.S and Tamna P.S , so we have informed the Officer-In-Charge of Tamna P.S and Bl&LRO, Purulia 1.They have also came to the spot. As there is no provision to use any machinery to operate sand mining, so the under signed seized the said Pokhland and handed over the same to the Tamna P.S for safe custody in presence of all officials.

Therefore, the undersigned is requesting you to treat this complain as FIR and to take necessary action as per the provision of law.
