Most Respectfully shweth:

- 1. That the complainant namely Nandalal Dutta present principle/H.O.D D.El.Ed college, Jabarrah, Hura, Purulia, had appointed the Accused namely Nina Barman, daughter of late Narendra Barman, 41, Mukherjee para lane, Srirampur, Hoogly, west Bengal for the post of Office Assistant/Clerk for D.EI.Ed. Course of Vasunddhara B.Ed & D.EI.Ed. College, located at village and post -Jabarrah, PS -Hura, District- Purulia, West Bengal with effect from 1st June 2019 as per the pay Scale and other perquisites of NCTE norms on 29/08/2018 the accused had been appointed as an Assistant Clerk cum Cashier in the above mentioned esteemed organization reposing complete faith upon her that she will discharge her duties as entrusted with utmost honesty and sincerity .Believing the accused, the college authorities have entrusted her with complete liberty to handle the cash of the institution as per requirement of the institution coming under the per-view of her works.
- 2. That very recently during the audit of the institution following defalcations of the accounts has been detected and appeared that the accused had withdrawn an aggregate sum of Rs. 61,316/- (sixty-one-thousand three hundred sixteen) from cash from time to time, i.e, on 21/09/2021 Voucher No. Dr-01 of amount 1080/-(one thousand eighty), subsequently on 2/10/2021 Dr-2 of amount 900/-(Nine hundred),13/11/2021 Dr-3 of amount Rs.3060/-(Three thousand sixty), 25/11/2021 Dr-03 Rs 5400/-(Five thousand four hundred), 04/12/2021 Dr-01 Rs 2160/-(two thousand one hundred sixty), 22/01/2022 Dr-01 Rs 360/-(three hundred sixty), 22/02/2022 Dr-01 Rs 45000/-





(forty five thousand) and none of the above Vouchers contains the signature of the recipient.

- 3. That further voucher no. Dr-01 dated 22/2/2022 there is a signature of the accused own self showing the acceptance of the said money from the treasury of the institute.
- 4. That again in other vouchers the accused had recorded huge expenses on labour for gardening, which is completely impractical and neither there were any signature of the labors, and when the management enquired for the same from the accused She stopped attending the institution on March 2022 without giving any particulars of the same.
- 5. That again on 14th February 2021 without any authority/ sanction of the management the accused disbursed Rs. 200000/-(two lakhs) to Mr. Anirudhya Mazumdar who happens to be the ex - secretary of the college and wrongly created voucher recording inter-alia that such money will be utilized for the purpose of interview of the faculty for the month of February(24th February2022).
- 6. That further more again on 2nd February 2022 the accused again withdrawn Rs 45000/-(forty five thousand) from the treasury of the trust for self same purpose which symbolizes that the accused was engaged in anti-trust activities with Anirudhya Mazumdar.
- 7. That the complainant also found that the accused had also collected fees from the students and not deposited the amount to the accounts department, rather deposited less amount than the collected amount which will amount to Rs. 183000(one lakh eighty three thousand) only. &
- 8. That on 21st June 2022 the accused came to the college premises with forged letter signed by Mr. Anirudhya Mazumdar as if he being the trustee of the college permitted the accused to join the college.
- 9. That the complainant lodged this complaint to the concerned PS on 9/12/22 but the OC hura PS did not take any action against the present accused person nor he



lodged any FIR in respect of the said complaint , then on 14/12/22 the complainant further informed to the SP purulia but till date no action had been taken . So the defacto complainant preferred to file this petition before your honour u/s 156(3)CrPC

It is, therefore, most respectfully prayed that Your Honour may graciously be pleased to accept by this petition and sent this complaint to OC Hura PS for lodging FIR and take necessary action in accordance with law
