Sub: Request for lodging F.I.R against offending driver namely Nirmal Bauri (40) S/O-
Sadhan Bauri of Vill+PO- Gourangdih, PS- Kashipur, Dist-Purulia.

Sir,

In producing herewith arrested offending driver namely Nirmal Bauri (40) S/O-Sadhan Bauri
of Vill+PO- Gourangdih, PS- Kashipur, Dist-Purulia along with one seized White Colour Pick up
Van bearing Registration No- WB37D-9289 loaded with straw in unsafe condition.

I, ASI Bipin Ch. Mahato of Hura PS beg to report that today myself along with C/1348
Santanu Kapri, C/1580 Alam Ansary and C/711 Durgapada Barik all of Hura PS were
performing anti-crime evening mobile duty on Puncha-Lalpur road under Hura PS vide Hura PS
CC No- 319/23 Dtd- 03.02.2023 & Hura PS GDE No. 115 Dtd- 03.02.2023 at about 18:30 hrs.
while we reached at Tekchangora near petrol pump under Hura PS, Dist- Purulia, we found that
one White Colour Pick up Van bearing Registration No- WB37D-9289 loaded with straw as
unsafe condition was coming from Puncha side and going towards Lalpur side rashly and
negligently and also unsafe condition loaded with straw. We try to stop that vehicle but the
driver of the said vehicle named in above was trying to escape the place so rashly, there was
every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase
we could able to stop the said vehicle at Lalpur more on NH 60A (Purulia – Bankura Road) under
Hura PS, Dist- Purulia. On being asked, he stated his name and address as noted above, but
unable to give any satisfactory account for his such rush and negligent driving which may cause
endanger to human life. Being asked to produce all relevant documents in respect of said vehicle
but he failed to produced any original documents in respect of said vehicle. Accordingly I seized
the White Colour Pick up Van bearing Registration No- WB37D-9289 loaded with straw and I
arrested the above noted accused driver under proper memo of arrest after disclosing the ground
of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC
read with section 184/190 of MV Act in presence of witnesses and informed him and his relatives
regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver
namely Nirmal Bauri (40) S/O-Sadhan Bauri of Vill+PO- Gourangdih, PS- Kashipur, Dist-Purulia
u/s 279 IPC read with section 184/190 of MV Act and arrange its investigation.
