Entered the premises of DEBEN MAJHI(BIDYA) , S/O:- SRIRAM MAJHI

and inspected his/ her premises. During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

From the above arrangement he/she uses the following electrical equipments.

1. Electric Motor- 01 nos.

Out of which I seized the following.

1. PVC two core cable fitted with hooking device approx length 52 feet's.

Seizure list was prepared at the site and accused person refuse to sign/signed.

The inspection team left the premises at 02.50. P.M. on 09.02.2023. The accused person has committed an offence U/S 135(1)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
