DHANESWAR GORAIN, resident at- BRAJAPUR, PS:- Jhalda, Dist- Purulia** was enjoying electricity unauthorized i.e. hooking from nearest LTOH line and due to this reason he

has committed theft of electricity U/S 135 (1/a) of the electricity (Amendment act-2007) on 09.02.2023 at 03.50 P.M.

and inspected his/ her premises. During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

Out of which I seized the following.

1. PVC two core cable fitted with hooking device approx length 65 feet's with one bulb.
