Sir,

In producing herewith the seized articles under proper seizure list (enclosed here with) i.e. (i) Exhibit Mark-'A' i.e. one transparent plastic Jaricane along with ash colored cap containing 2.890 grams (including Jaricane) of light red colored codeine mixture (from which samples of 2 bottles of approx 100 grams each taken out for test samples and security samples marked as Exhibit 'B1' & 'B2' (ii) Exhibit mark - 'B1' containing 0.152 grams (including bottle) of codeine as test sample. (iii) Exhibit mark 'B2' containing 0.148 grams (including bottle) of codeine as security sample. (iv) One old tin made box length approx 22 inches, width approx 12 inches height approx 7 inches marked as Exhibit 'C' (v) one lock style as Voltas Hero 5 Lever's with its key. All Exhibits are in properly sealed and labeled condition under proper seizure list before you. I SI Montaz Sheikh beg to submit that on 09/02/2023 I along with other officers namely ASI Khirod Baran Sardar interrogated the PC accused person namely Sk Abdul Malik @ Abdul Malik @ Hati S/O Late Sk Manu of vill- Hussaindih, PS- Jhalda, Dist Purulia in C/W Jhalda PS Case no 104/22 dated 13/06/2022 U/S 395 IPC & 25 (1) (a) /35 Arms act adding section 412/413 of the IPC at this PS. He confessed his guilt and the PC accused stated that he along with others co accused committed dacoity in the house of Bhagirath Mahato of Masina in the 12/13- 06 -2022 night. He along with Moiuddin Ansuary S/O Late Liyakat Ansuary of Vill- Shyamdih, PS Katras Dist- Dhanbad hatched up a plan to commit house dacoity in that house and they formed team and most of them regularly consumed codeine mixture. However, the PC accused also stated that before commission of crime all the dacoits consumed codeine which he supplied. He also stated that during the commission of dacoity he possessed crude bombs which he kept in a secret place in his house and he would help the police for recovery the same. Subsequently, I recorded his statement U/S 161 Cr.P.C and diarized the matter vide Jhalda PS GDE no 454 dated 09/02/2023 and informed whole the matter to you. Thereafter, I interrogated the said PC accused again in presence of you and he further stated that he used to run a codeine mixture business before the commission of crime and the said mixture of Codeine kept in a lock and key in a small trunk in his house and the said trunk none other than he used. I further recorded his statement U/S 161 Cr.P.C in a separate sheet of paper and diarised the matter vide Jhalda PS GDE no 455 dated 09/02/2023. Accordingly, as per your direction, I along with ASI Khirod Baran Sardar and C/186 Ananda Das C/ 898 Dipankar Patra JC/1452 Yudhisthir Kumar, LC/3049 Parul Mahato accompanied with the PC accused namely Sk Abdul Malik @ Abdul Malik @ Hati S/O Late Sk Manu of vill- Hussaindih, PS- Jhalda , Dist Purulia left the PS vide Jhalda PS GDE no 458 dated 10/02/2023 in consonance with Jhalda PS CC no 452 dated 10/02/2023 with Govt. Vehicle No WB 56C 5712 for Hosseindih village to work out the same. Before leaving the PS I took the necessary

inventory items of mandatory articles like some white A4 seized papers, three piece carbon papers, some brown papers, three piece blue ball pen, one rubber, stamp pad of Jhalda PS, electronic weight machine of PS (ranging from 40 grms to 30 Kgs.), sealing wax, brass seal, candle, match box, needle (one) thread, gum, scale one piece, sample & sample security empty bottles 2 pcs, one black ball pen, search light after preparing inventory list. We arrived at Nayamore under Jhalda PS waited for executive Magistrate and SDPO Jhalda but you informed over telephone at 00:38 hrs that executive magistrate would not be available at the night and SDPO Jhalda being a gazetted officer would be available and arriving at me. We tried to accompany with any public witness but due to the dead night no public witness was available with us. Despite of that PC accused is a dangerous criminal, being frightened none turned up as witness.

Around 00:55 hrs Shri Subrata Deb SDPO Jhada arrived at Naya More under P.S Jhalda, Purulia. Subsequently, I along with officer and forces and the PC accused accompanied with SDPO Jhalda left the Nayamore for the Hossendih village as per the leading statement of the PC accused. On 10.02.2023 at 01:05 hrs we arrived at the house of PC accused in Hosseindih village and SDPO Jhalda issued notice in writing upon said PC accused namely Sk Abdul Malik @ Abdul Malik @ Hati S/O Late Sk Manu of vill- Hussaindih, PS- Jhalda, Dist Purulia whether he was willing to search the body of Gazetted officer along with other accompanying officer and force. The content of notice was read over him and asked him that he had legal rights to search all the members of raid party before entering into his house for the search process of his house. He conducted a search of all the members of us but nothing objectionable could be found on our person except our personal belongings. Govt. arms and ammunition and items mentioned in the inventory list.

In presence and under the supervision of Shri Subrata Deb SDPO Jhada, house search process was conducted and during search the PC accused Sk Abdul Malik @ Abdul Malik @ Hati S/O Sk Manu of vill- Hussaindih, PS- Jhalda, Dist Purulia took out one tin made old trunk from his room at his dwelling house and opened it by a key which he kept in a secret place. After opening the trunk it was found one transparent plastic Jaricane along with ash colored cap containing light red colored liquid which seemed as contraband like substance. After opening the jaricane an aromatic smell was found. We are in strong believe that it was codeine mixture and on interrogation said the PC accused Sk Abdul Malik @ Abdul Malik @ Hati S/O Sk Manu of vill- Hussaindih, PS- Jhalda, Dist Purulia admitted that he was habituated in dealing of such clandestine illegal business of Codeine for commercial purpose for his wrongful gain, knowing the same is a punishable offence. On demand he failed to produce any valid documents or justify regarding the storage of huge quantity of contraband codeine mixture. According to the direction of SDPO Jhalda I weighed the Jaricane and it resulted in 2.890 grams including Jaricane in electronic weighing machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believed to be codeine mixture from which approx 0.152 grms including bottle was taken as test sample in a bottle and approx 0148 grams including bottle was taken as security sample in another bottle, one old tin made box

length approx 22 inches, width approx 12 inches height approx 7 inches, one lock style as Voltas Hero 5 Lever's with its key. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as the accused in between 01:35 hrs to 02:25 hrs. No public witness was available there due to the dead hours of night. Despite of that PC accused is a dangerous criminal, being frightened none turned up as witness. I also supplied a copy of seizure list to the accused. The seized articles were properly sealed and labeled in presence of SDPO Jhalda.

In between 02: 45 hrs to 03:05 hrs I prepared another inventory list of remaining articles (after the use), two white A4 size paper, one fresh and two used carbon, brown paper, 1 used blue ball pen and two unused ball pen, one rubber, stamp pad of Jhalda PS, electronic weight machine of PS sealing wax, brass seal, burn candle, match box, needle (one) thread, gum, scale one piece, search light, one black ball pen, one transparent plastic jaricane along with ash colour cap containing 2.890 grms (including jaricane) of light red colour codeine mixture from which samples of two bottles one lock style as voltas hero five levers with its key, one old tin made box in presence of witnesses and the PC accused. The entire process was directly supervised by Shri Subrata Deb SDPO Jhadada and video graphed.

The accused person are liable for prosecution U/S- 21(C) /29 of NDPS Act 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against the PC accused Sk Abdul Malik @ Abdul Malik @ Hati S/O Sk Manu of vill- Hussaindih, PS- Jhalda , Dist Purulia U/S- 21(C)/29 of NDPS Act. 1985 as amended up to date and arrange for its investigation.
