Sir,

I, ASI Khageswar Kumar along with force returned to PS and brought under seizure approx 09 Ton steam coal in total piled at the PO i.e. at the cowshed of Binod Gorain (46) S/O Lt. Budhu Gorain of Vill-Madhupur, PO-Brajapur, PS-Jhalda, Dist-Purulia under proper seizure list and produced before your good self.


The fact in brief is that today (12/02/2023) I along with force namely i) JC/1463-Samsuddin Ansary (ii) NVF/778-Samir Chandra Mahato (iii)HG/1772-Fatik Kumar all of Jhalda PS were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 595 Dated- 12/02/2023 in consonance with Jhalda PS CC No- 478 /23 Dated- 12/02/2023. During my evening mobile duty, at about 22:05 hrs, I received credible tip off that illegal steam coal was stock at the cowshed of Binod Gorain (46) S/O Lt. Budhu Gorain of Vill-Madhupur, PO-Brajapur, PS-Jhalda, Dist-Purulia. Subsequently I, informed to you as well as to the duty officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 609 Dated 12/02/2023 and I proceeded to the spot to work out the information. Consequently, we arrived at the spot on 13/02/23 at about 00:15 hrs and found that approx 09 Ton steam coal in total piled at the PO i.e. at the cowshed of Binod Gorain (46) S/O Lt. Budhu Gorain of Vill-Madhupur, PO-Brajapur, PS-Jhalda, Dist-Purulia which was as identical as I received prior information. But seeing the Police Party, the person namely Binod Gorain flee away leaving the said amount of coal at the spot. We tried to apprehend him but failed. We waited for reasonable time but none came to spot. During the endemic enquiry it came to reveal that Binod Gorain (46) S/O Lt. Budhu Gorain of Vill-Madhupur, PO-Brajapur, PS-Jhalda, Dist-Purulia along with Naresh Gorain of Madhupur village, Ramesh Mahato of Madhupur village and others was carrying and unloading the steam coal at the spot and the said Binod Gorain is the kingpin of this illegal act. It was ascertained that Binod Gorain and others loaded the said steam coal from illegal coal mines from Jharkhand state in cahoots with the land owner by illegal mining and tried to sell the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that the said persons in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized approx 09 Ton steam coal in total piled at the PO i.e. at the cowshed of Binod Gorain (46) S/O Lt. Budhu Gorain of Vill-Madhupur, PO-Brajapur, PS-Jhalda, Dist-Purulia after preparing proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the said seizure article by arranging another goods vehicle to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accd. person namely Binod Gorain (46) S/O Lt. Budhu Gorain of Vill-Madhupur, PO-Brajapur, PS-Jhalda, Dist-Purulia and Naresh Gorain of Madhupur village, Ramesh Mahato of Madhupur village and others as they committed offence U/S- 379/411/414/120B of the IPC.
