Sir,

In producing here with arrested accused persons namely 1) Kharu @ Sk Ashir (27) S/O Sk Harmuj of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia & 2) Rampada Kandur (62) S/O Lt. Kalipada Kandur of Jhalda Anandabazar, Ward No-2, PS-Jhalda, Dist-Purulia and seized articles (i) One Iron Rod length approx 3.5 ft (ii) One Bhujali attached with Bamboo handle length approx 1.5 ft and sharp edge of Bhujali is approx. 11 inches (iii) one nylon rope in red colour length approx 18 mtr lodged complain against them and 14/15 others 1) Bhalka 2) Sk Saddam 3) Sk Imroj @ Moja all of Vill- Kantadih, PS- Jhalda, Dist- Purulia and 4) Jamir of Hussendih, PS- Jhalda, Dist- Purulia were among them to the effect that on 22/02/2023 at about 23.25 Hrs during my night mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled in an open place near Saldaha Bridge situated at Gopalpur village road and they were preparing themselves for committing dacoity at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 1106 Dated 22/02/2023. On getting the tip off as per kind order myself accompanied with force who were detailed for the Night Mobile Duty with me namely (i) C/214 Siddhartha Mandal (ii) JC/1463 Samsuddin Ansary (iii) NVF/1036 Pramatha Kuiry and (iv) HG/1807 Shyam Sing Laya all of Jhalda PS vide CC No. 600 dated 22/02/2023 & vide Jhalda PS GDE NO 1097 Dated 22/02/2023 immediately proceeded to the anticipated place of assembly to work out the information and reached near Saldaha Bridge at 23:55 Hrs leaving the Police vehicle No- WB 56C 5712 and started to proceed for the anticipated place on foot. At 00:05 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 16/17 persons assembled in an open place near Saldaha Bridge situated at Gopalpur village road 50 mtr away from Saldaha Bridge and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 02 (two) of them at 00:15 Hrs while the rest 14/15 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person (i) One Iron Rod length approx 3.5 ft from the possession of Kharu @ Sk Ashir, and (ii) One Bhujali attached with Bamboo handle length approx 1.5 ft and sharp edge of Bhujali is approx 11 inches (iii) one nylon rope in red colour length approx 18 mtr the possession of Rampada Kandur. Subsequently, I seized in between 00:35 hrs to 01:15 hrs on 23/02/2023 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, (i) One Iron Rod length approx 3.5 ft (ii) One Bhujali attached with Bamboo handle length approx 1.5 ft and sharp edge of Bhujali is approx 11 inches (iii) one nylon rope in red colour length approx 18 mtr from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat. On interrogation they confessed their guilt and they stated that they have assembled there with 14/15 others, 1) Bhalka 2) Sk Saddam 3) Sk

Imroj @ Moja all of Vill- Kantadih, PS- Jhalda, Dist- Purulia and 4) Jamir of Hussendih, PS- Jhalda, Dist- Purulia were among them for committing a house dacoity in a Maru family at Jhalda Town .I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonable to believe that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Kharu @ Sk Ashir (27) S/O Sk Harmuj of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia & 2) Rampada Kandu (62) S/O Lt. Kalipada Kandu of Jhalda Anandabazar, Ward No-2, PS-Jhalda, Dist-Purulia along with 14/15 others, 1) Bhalka 2) Sk Saddam 3) Sk Imroj @ Moja all of Vill- Kantadih, PS- Jhalda, Dist- Purulia and 4) Jamir of Hussendih, PS- Jhalda, Dist- Purulia were among them and others under proper section of law.
