
In producing herewith the seized articles 08 Pieces of extracted Sandalwood in different size and weight with different diameter in a nylon sacks weighing approx 20 KGs under proper seizure list before you. I SI Sujit Das beg to submit that today on 02/02/2023 I along with other officers namely SI HabiburRahaman and ASI KhirodBaranSardar interrogated both the PC accused persons namely SK Mehaboob @ Alua 37yrs S/O Sk Belal of vill- Kantadih , PS Jhalda Dist- Purulia and Md Shakeel Ahamed 46 yrs S/O Lt Jahir Khan of Mira Tola, Jama Masjid , PS- Kannauj, Dist- Kannauj (UP) in C/W Jhalda PS Case no 16/23 dated 24/01/2023 U/S 399/402 of the IPC & 25(1)(a) /35 of the Arms Act 1959 at this PS. They confessed their guilt and both the PC accused stated that they were assembled with 11/12 others namely Bhalka of Kantadih, Kamal of Kantadih, SkImroj of Kantadih, Jamir of Hussendih, Butla of Kantadih and others for committing a dacoity in Sikra Mountain & Hill Resort they also stated that another improvised fire arms which was handed over by Md Shakeel Ahmed was kept in a secret place in the house of SK Mehaboob @ Alua and they would help the police for recovery the same. Subsequently, I recorded the statement of them U/S 161 Cr.P.C and diarized the matter vide Jhalda PS GDE no 77 dated 02/02/2023 and informed you. Consequently, as per your direction, I along with ASI Khirod Baran Sardar and C/240 Manaranjan Bagdi C/ 214 Sidhartha Mandal NVF/933 Abani Kumar accompanied with both the PC accused namely SK Mehaboob @ Alua 37yrs S/O SkBelal of vill- Kantadih , PS JhaldaDist- Purulia and MdShakeelAhamed 46 yrs S/O Lt Jahir Khan of Mira Tola, Jama Masjid , PS- Kannauj, Dist- Kannauj (UP) left the PS vide Jhalda PS GDE no 78 dated 02/02/2023 concomitant with Jhalda PS CC no 361 dated 02/02/2023 for Kantadih village to work out the same. Before entering into the Kantadih village, I stopped at Bandha ghat more and invited two disinterested witnesses namely 1) Aminuddin Kazi S/O Lt Sk Kayum Kazi of Hossaindih 2) Chandan Roy S/O Monotosh Kumar Roy of Ward no 4 near Jhalda old PS both of PS- Jhalda Dist- Purulia and asked them the matter and requested to accompany with us and they agreed. Thereafter we arrived at the house of SK Mehaboob @ Alua 37yrs S/O Sk

Belal of vill- Kantadih, PS Jhalda Dist- Purulia at 14:45 hrs. During the search in presence of witnesses we perceived a cogent smelling of Sandal, I further interrogated both the PC accused in presence of disinterested witnesses they denied the matter of fire arms but stated that they were involved to run illegal clandestine business of sandal wood to carry/transport to Uttar Pradesh State by cutting and stealing the sandal tree from the different forest area of Purulia and Bankura District. Consequently, as per their leading statement at 15:45 hrs I recovered 08 Pieces of extracted Sandalwood in different size and weight with different diameter in a nylon sacks weighing approx 20 KGs under a cot in the house of SK Mehaboob @ Alua 37yrs S/O Sk Belal of vill- Kantadih , PS Jhalda Dist- Purulia. On asking they could not able to produce any valid document in respect of the sandal wood this reasoned to believe that it was stolen or procured by any illegal means. Subsequently, I seized 08 Pieces of extracted Sandalwood in different size and weight with different diameter in a nylon sacks weighing approx 20 KGs after preparing proper seizure list in presence of witnesses duly signed by them as well as accused persons and labeled the same and informed you regarding the matter.

In the above circumstances, I submit that to initiate a case against SK Mehaboob @ Alua 37yrs S/O Sk Belal of vill- Kantadih , PS Jhalda Dist- Purulia and Md Shakeel Ahamed 46 yrs S/O Lt Jahir Khan of Mira Tola, Jama Masjid , PS- Kannauj, Dist- Kannauj (UP) U/S 379/411/413/414 read with section 51(a)(d) of the Indian Forest Act 1927.


