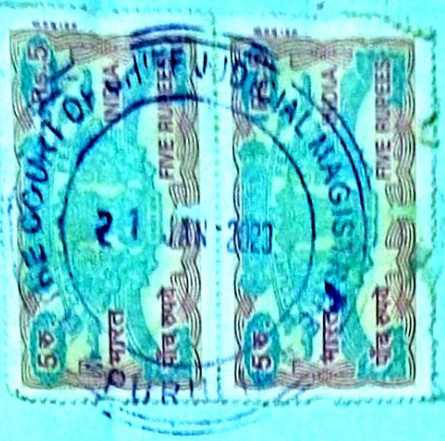

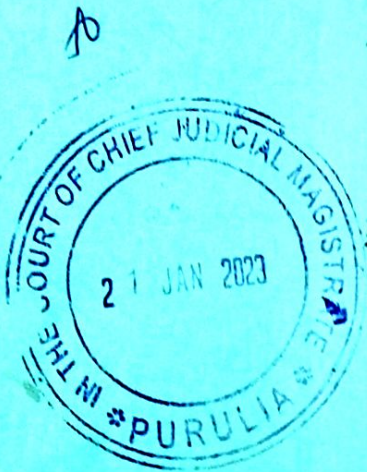

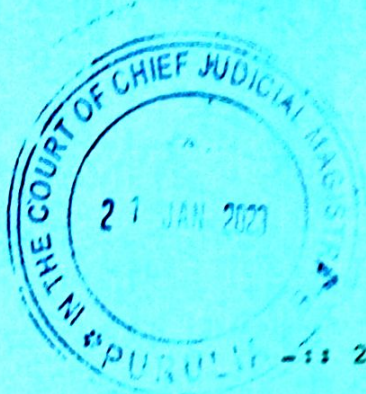

Most respectfully stated as follows:-

- 1.---That the complainant, accused persons both are residing at village-Narayanpur under P. 3, Joypur, District Purulia.
- 2.---That on dated 06-01-2010 Idrish Ansari son of late Abdul Ansari and Jan Mohammad Ansari son of Ramjan Ansari of village Narayanpur under P. 3, Joypur, Dist. Purulia obtained the schedule land through family Settlement and when they were in possession over the schedule land, They sold the schedule land in favour of Nasiruddin Ansari son of late Afjal Ansari vide Regd. Sale Deed No. 62/2010 since purchase Nasiruddin Ansari was in possession over the schedule land.
- 3.---That due to medical treatment of Nasiruddin Ansari proposed to sale the schedule land and the complainant agreed to sale the schedule land and he purchased the schedule land vide Regd Sale Deed No. 4911/2014 with adequate consideration of money. Since purchase, he constructed one Room and the complainant and his family members are residing thereon.
- 5.---That on 24-12-2022 corresponding to 8th Pose 1429 B. S. most illegally wrongfully armed with deadly weapons above named accused persons entered into the house of the complainant and started using filthy languages aiming the complainant. Then the complainant protested of their illegal activity, then the accused persons started assault by fist and blow and Lathi. As a result the complainant fell
