Sub – Prayer for lodging FIR

Respected Sir,

In producing herewith arrested accused person Surajmoni Soren (42 Years) W/O Anil Soren of village – Lara Uppar Para, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 18.02.2023 at 12.25 hrs during my mobile duty received telephonic information that the above noted accd. selling liquor at Lara Uppar para village in her house. Accordingly I, SI Santosh Kr Sardar along with LC/126 Sabitri Saren & C/730 Tapas Mandal and C/1208 Suresh Hembram reached at Lara Uppar Para village in her house of the above noted accused at 13.15 hrs and found that one person was selling Id Liquor(Chullu) in her house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in her possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found One white colour plastic jarikin loaded with approx 20 (Twenty) liters ID liquor (Chullu) out of seized ID liquor 300 ml taken out in a bottle as sample with sealed and labeled. I also seized and labeled all the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 13.55 hrs u/s - 67 Bengal Excise Act 1909 and informing her the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused person Surajmoni Soren (42 Years) W/O Anil Soren of village – Lara Uppar Para, PS - Kashipur, Dist - Purulia and arrange for its investigation.
