subsequently the complainant came to know that the above named accused person by in collusion with each other by hatching a criminal conspiracy kidnapped or abducts the daughter of the complainant from the lawful guardianship and secretly and wrongfully confined her for any illegal purposes.

4. That after knowing the facts, the complainant again went to Kotshila P.S in order to lodge a complaint, but the reason is unknow, they refused to lodge any case.
5. That subsequently, the Complainant on 25.01.2023 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to officer-in-charge of Kotshila P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
