Sir,

In producing herewith 01 (one) arrested accd. person namely Nagen Mahato (35 yrs) s/o Lt Tulsiram Mahato of vill.-Urusaram, PS-Kotshila, Dist.-Purulia along with one seized red colour tractor bearing registration no. WB-55B/4717 (Chassis No. MBNABAEXKMRM05293, Engine No. RMM2EAN1249) - model - Mahindra & Mahindra Limited (Tractor) B 275 DI Bhoomiputra attached with trolley loaded sand 100 (one hundred) cft (approx) under proper seizure list, I beg to submit that today (17.02.2023) I along with (1) C/983 Radhakanta Kisku (2) C/332 Ashok Kr Kandau both of Kotshila P.S were performing special Mobile duty vide Kotshila PS. Spl CC No. 16/2023 Date-. 17.02.2023. During my special mobile duty at about 19.05 hrs I along with force reached at Mahultanr village near Kotshila Girls School under Kotshila PS and found that one red colour tractor having Reg. No. WB-55B/4717 (Chassis No. MBNABAEXKMRM05293, Engine No. RMM2EAN1249) - model - Mahindra & Mahindra Limited (Tractor) B 275 DI Bhoomiputra attached with trolley loaded with sand was coming from Tigra village side. On seeing the Police party at Mahultanr village near Kotshila Girls School, the driver of the said tractor tried to flee away. But after a hot chase, we could able to detain the driver of said tractor. On asking he disclosed his identity as Nagen Mahato (35 yrs) s/o Lt Tulsiram Mahato of vill.-Urusaram, PS-Kotshila, Dist.-Purulia. I asked the driver Nagen Mahato to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running clandestine business with owner. So, I seized the tractor having Reg. No. WB-55B/4717 (Chassis No. MBNABAEXKMRM05293, Engine No. RMM2EAN1249) - model - Mahindra & Mahindra Limited (Tractor) B 275 DI Bhoomiputra attached with trolley loaded sand 100 cft (approx) in between 19.15 hrs to 19.25 hrs under proper seizure list in presence of available witnesses duly signed by them and also accd. person and I arrested Nagen Mahato (35 yrs) s/o Lt Tulsiram Mahato of vill.-Urusaram, PS-Kotshila, Dist.-Purulia at 19.35 hrs. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document. So they are liable for offence punishable U/S 379/411/414/120B IPC. & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the arrested accused driver namely Nagen Mahato (35 yrs) s/o Lt Tulsiram Mahato of vill.-Urusaram, PS-Kotshila, Dist.-Purulia and owner of the tractor having Reg. No. WB-55B/4717 (Chassis No. MBNABAEXKMRM05293, Engine No. RMM2EAN1249) - model - Mahindra & Mahindra Limited (Tractor) B 275 DI Bhoomiputra may kindly be started and arrange for its investigation.
