In producing herewith the arrested accd. persons namely 1) Alok Mahato @ Bablu (30 yrs) S/O-Jagadish Mahato and Prankrishna Mahato @ Panu (27 yrs) S/O- Lt. Sudhir Mahato both of Vill- Jargaria, PS-Boro, Dist-Purulia and one seized tractor without number plate having Engine No. NNE6C7E0037 and Chasis No MBNPFANUPNNE00974 Mahindra Yuva Tech 585 DI (Red Colour) fitted with approx 100cft sand loaded Trolley as per seizure list.

I would like to draw your kind attention regarding the fact of the case in brief is that I ASI Sambal Singh along with C/45 Samir Mahato and HG/1419 Santanu Mahato were engaged in Day mobile duty vide Manbazar P.S C.C No 481/23 and GDE No- 568 dt- 23.02.2023. Then at 10:35 hrs received a credible source information that the above noted vehicle (Tractor) is lifting sand illegally at Janara on Kumari river bed at village- Janara under PS- Manbazar, Dist- Purulia. As the area is far from PS and interior place hence extra force was required. Madhyamik exam is going on. Other officer force of Manbazar PS were engaged in M.P exam duty hence informed the matter to OC Manbazar PS. As per his order I along with my accompanied force and C/2187 Ujjwal Das, C/2603 Fatik Ch Mahato, C/3023 Angshuman Mondal and C/2114 Subrata Patra of Manbazar EF Line left to work out the information. At 11:25 hrs when we reached near Janara village found the above noted tractor was coming from Janara river bed. Seeing the police party, driver of the tractor fled away with his tractor from the spot. Then we chased the tractor and after a hot chase we could be able to detain the said tractor at Jargaria village under Boro PS. Accordingly informed OC Boro PS. We searched the said tractor and found that the tractor is loaded with approx 100 cft sand with attached trolly, without number plate. Engine No. NNE6C7E0037 and Chasis No MBNPFANUPNNE00974 Mahindra Yuva Tech 585 DI (Red Colour). On asked the person sit on the seat of driver disclosed his identity as Alok Mahato @ Bablu (30 yrs) S/O- Jagadish Mahato of Vill- Jargaria, PS- Boro, Dist- Purulia. On demand he could not able to produce any valid document in respect of the said tractor as well as the sand loaded on it. During this process suddenly the driver Alok Mahato started shouting and called few persons to the spot. As we detained the said tractor in the village hence hearing the shouting 7-8 people of that village rushed to the place. They including the driver Alok Mahato were very adamant in nature. They started to push me including my accompanied Police personnel. Also started to hit us by fist and blows causing obstruction in discharge of our duty. In this incident C/2187 Ujjwal Das, C/2603 Fatik Ch Mahato, C/3023 Angshuman Mondal and C/2114 Subrata Patra of Manbazar EF Line received injuries on their persons. Finding no other alternative I called for reinforcement. Officer force of Boro PS and Manbazar PS rushed to the spot. Seeing many officer and force, the miscreants tried to flee away but we managed to detain the driver Alok Mahato and Prankrishna Mahato. On asked they confessed their guilt. They also disclosed the identity of other miscreants as Sandip Mahata, Apurba Mahato S/O- Lt. Bipadtaran Mahato, Balaram Sahis S/O- Subhas

Sahıs, Ganesh Mahato S/O- Lt Chunaram Mahato and 7-8 others of Jargaria village, PS- Boro. On asked driver Aloke Mahato stated that he along with the owner of the vehicle is running the business of illegal transportation of sand since long. They are habituated in it. Hence there is every reason to believe that the driver and owner of the above-mentioned Tractor with ill motive are transporting sand illegally without any valid document in support of carrying / Lifting sand and they habitually deal with the business of stolen sand in a clandestine manner since long for their wrongful gain. Accordingly I arrested 1) Alok Mahato @ Bablu (30 yrs) S/O- Jagadish Mahato and Prankrishna Mahato @ Panu (27 yrs) S/O- Lt. Sudhir Mahato both of Vill- Jargaria, PS- Boro, Dist- Purulia as well as seized the said tractor attached with trolley loaded with approx 100 cft sand under proper seizure list and brought to Manbazar PS for legal action. Injured Police personnel were treated at Manbazar Rural Hospital.

Therefore, I pray before you that a case may kindly be started as per law and arrange for its
