Sir,

In producing herewith three accused persons namely 01) Rinku Sekh (28Yrs) S/O- Najir Sekh of Raibandh, PS- Neturia, Dist- Purulia (Driver of the seized vehicle having registration number WB81-1586) 02) Prasanta Mahato (29Yrs) S/O- Lt. Umapada Mahato of Raibandh, PS- Neturia, Dist- Purulia (Driver of the seized vehicle having registration number WB81-1486) and 03) Manbodh Mondal (32Yrs) S/O- Lt. Sudhir Mondal of Raibandh, PS- Neturia, Dist- Purulia (Owner of the seized vehicle having registration number- WB81-1486) and along with two seized tractors with trolley loaded with approx 06 MT steam coal (03 MT in each tractor) seized from Hansapathar Morh under Neturia PS, Dist- Purulia do hereby lodge a written complaint to the effect that on 21/22.02.2023, I ASI Bachchu Ghosh along with C/939 Laltu Paul, C/564 Prasad Majhi and C/1568 Debojyoti Sinha all are of Neturia PS Dist Purulia were performing PS area night mobile duty vide Neturia PS GDE No- 953 dt. 21.02.23 & CC No-544 Dt. 21.02.23. During mobile duty on 22 .02.23 at about 00.15 hrs received a source information that two number of tractors along with trolley loaded with coal coming from Raibandh side. Shared the information to my superiors and as ordered I along with force immediately left for Raibandh side and started Naka at Hansapathar More at about 01:25 hrs on 22.02.23 and found that above noted two tractors with trolley loaded with coal were coming from Raibandh side . Seeing the Police party suddenly the drivers of the both vehicles stopped the tractors (WB 81-1486 and WB 81-1586) at Hansapathar Morh. They got down from the vehicles and started to run towards the village area. We chased to apprehend them and manage to apprehend the above noted three accused persons. On being asked to produce any valid documents in support of coal loaded in two tractors with trolley, they failed to produce any valid document. Accordingly, I seized raw coal seems to be steam approx 06 MT (03 MT in each tractor) from the possession of the two drivers of the said tractors under proper seizure list duly signed by them and witnesses. Accordingly I arrested the two drivers of the seized vehicles 01) Rinku Sekh (28Yrs) S/O- Najir Sekh of Raibandh, PS- Neturia, Dist- Purulia (Driver of the seized vehicle having registration number WB81-1586), 02) Prasanta Mahato (29Yrs) S/O- Lt. Umapada Mahato of Raibandh, PS- Neturia, Dist- Purulia (Driver of the seized vehicle having registration number WB81-1486) and 03) Manbodh Mondal (32Yrs) S/O- Lt. Sudhir Mondal of Raibandh, PS- Neturia, Dist- Purulia (Owner of the seized vehicle having registration number- WB81-1486) after maintaining arrest rules . On interrogation they disclosed the name of their accomplices namely Ananda Mondal S/O- Lt Chhutu Mondal of Raibandh, PS- Neturia, Dist- Purulia (Owner of the seized vehicle WB81-1586), Hiru Barui S/O- Lt Sasadhar Barui of Dumurhir, PS- Neturia, Dist- Purulia and others were engaged in procuring the illegal coal and transporting the same in a clandestine manner to another district/state.

So, it is reasonable to believe that the arrested accused persons 01) Rinku Sekh (28Yrs) S/O- Najir Sekh, 02) Prasanta Mahato (29Yrs) S/O- Lt. Umapada Mahato and 03) Manbodh Mondal (32Yrs) S/O- Lt. Sudhir Mondal all of Vill- Raibandh, PS- Neturia, Dist- Purulia and involved accused persons namely 04) Ananda Mondal S/O- Lt Chhutu Mondal of Raibandh, PS- Neturia, Dist- Purulia, 05) Hiru Barui S/O- Lt Sasadhar Barui of Dumurhir, PS- Neturia, Dist- Purulia and others procured the said coal either by theft or by any fraudulent means from the illegal coal pits and trying to dispose the same coal in a clandestine manner to another district/state knowing it to be stolen. After seizure necessary arrangement has been made for shifting the seized coal at Neturia PS.

Therefore, I pray that a specific case may kindly be registered against accused 01) Rinku Sekh (28Yrs) S/O- Najir Sekh, 02) Prasanta Mahato (29Yrs) S/O- Lt. Umapada Mahato, 03) Manbodh Mondal (32Yrs) S/O- Lt. Sudhir Mondal all of Vill- Raibandh, PS- Neturia, Dist- Purulia, 04) Ananda Mondal S/O- Lt Chhutu Mondal of Raibandh, PS- Neturia, Dist- Purulia, 05) Hiru Barui S/O- Lt Sasadhar Barui of Dumurhir, PS- Neturia, Dist- Purulia and others under proper section of law.
