Sub:- Complain for starting a specific case .

Sir.

In producing herewith the seized Tractor along with trolley having registration No- WB 88C/7687 loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, ASI Bachchu Ghosh, along with C/399 Kartik Mura, C/2016 Basak Roy and C/1460 Rajat Mukherjee all are of Neturia PS were performing mobile duty vide Neturia PS GD No- 536 Dt. 12.02.23 & CC No- 438/23 Dt. 12.02.23 at PS area and on 12.02.2023 at about 10:45 hrs received a credible source information that one tractor loaded with illegal sand in trolley coming from Benipur side towards Sarbari side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Nimdanga More and at about 11:15 hrs reached at Nimdanga More found that above noted tractor was coming from Benipur side and suddenly the driver stopped the tractor there after seeing the police party then he got down from the tractor and started running towards the village area. We chased to apprehend the person but in spite of hot chase he managed to flee away. Then we searched the tractor and found that the vehicle (tractor) having registration No- WB 88C/7687 has been loaded with sand approx 100 Cft.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen.

Accordingly, I seized the tractor along with trolley bearing No WB 88C/7687 loaded with sand approx 100 C.Ft. at 11:35 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the vehicle have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of vehicle No- WB 88C/7687 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
