Sub:- Complain for starting a specific case .

Sir.

In producing herewith the seized Tractor along with trolley without registration No. having Engine No- 33.100S/SENO9648, Chassis No-MBNAG48ACNTP79511 (Make- Swaraj, Model-S34XM) loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, SI Shib Narayan Singh, along with C/174 Tapan Das Bauri and C/1550 Bharat Ghosh all are of Neturia PS were performing mobile duty vide Neturia PS GD No- 537 Dt. 12.02.23 & CC No- 439/23 Dt. 12.02.23 at PS area and on 12.02.2023 at about 14:05 hrs received a credible source information that one tractor loaded with illegal sand in trolley coming from Madhukunda side towards Sarbari side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Murgaboni More and at about 14:25 hrs reached at Murgaboni More and found that above noted tractor was coming from Madhukunda side and suddenly the driver stopped the tractor there after seeing the police party then he got down from the tractor and started to run towards the jungle area. We chased to apprehend the driver but in spite of hot chase he managed to flee away. Then we searched the tractor and found that the vehicle (tractor) without registration No. having Engine No- 33.100S/SENO9648, Chassis No-MBNAG48ACNTP79511 (Make- Swaraj, Model-S34XM) has been loaded with sand approx 100 Cft.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen.

Accordingly, I seized the tractor along with trolley without registration No. having Engine No- 33.100S/SENO9648, Chassis No-MBNAG48ACNTP79511 (Make- Swaraj, Model-S34XM) loaded with sand approx 100 C.Ft. at 14:45 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the vehicle have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of vehicle without registration No. having Engine No- 33.100S/SENO9648, Chassis No-MBNAG48ACNTP79511 (Make- Swaraj, Model-S34XM) U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
