During inspection it was found that, Sri Ramashankar Nunia was consuming electricity unauthorisedly and dishonestly in his domestic Premises By directly hooking from our nearby LTOT Line with hooking arrangements

So that less energy consumption recording in energy meter which resulted causing huge loss of revenue of WBSEDCL to tune of load 2.076kW.

The 2 nos of energy meter bearing meter no. BR 366 809 & SE 0007830 respectively.

The meter no SE0007830 disconnected from the Pole & others one disconnected from meter P.P. Box and sealed vide Serial SEH 0882516.

As theft of electricity detected during inspection the hooking arrangement also removed. The hooking arrangement has been seized under memo of seizure list duly signed by accused person in the notice, inspection Report.

The inspection team left the Premises at about 2.50 P.M. on 24.02.2023.

The accused committed theft of electricity u/s 135 (1)(a) of the electricity Act-2003, Amendment-2007.

You are requested to take cognizance of the complaint & treat this as F.I.R and take necessary action.
