Sub: An application for the lodge of F.I.R regarding a road traffic accident Sir.

I Sankar Bouri S/O Paresh Bouri , resident of Kalikapur , Saltora Bankura P.O-Pachandapur , P.S- Santuri Dist- Purulia , beg to inform you that on 16.02.2023 at about 7: 30 – 8:00 P.M (night) when my elder brother Bikram Bouri ( 28 years ) with his friend as a pillion rider name - Kapil Hembram S/O Ruplal Hembram residence of Poradiha , Pachandapur , P.S- Santuri Dist- Purulia were going from their working place Ceramic Factory at Poradiha to another place for their factory related work by riding a motorcycle through Madhukunda to Sarbari Road being WB-82-C-8846; when they reached near Murgabani More under P.S- Nituria , at that time one Maruti Breeza Car being No. WB-74-BC-8145 dashed my motorcyclist brother from behind in rash and negligent manner and with high speed. As a result of such accident my brother with his pillion rider friend fell down extreme left side of the road with his motorcycle and sustained severe bleeding injuries. Immediately the local people shifted them to Harmadih Health Center , thereafter they were taken to Durgapur Mission Hospital Hospital for better treatment , where the doctor examined declared them brought dead .

Both of the victims Post- Mortem examination was held at Sub- Divisional Hospital Durgapur, Dist- Paschim Bardhaman.

About this accident, two U/D Case N.T.S P.S Case No. 89/2023 dt- 17.02.2023 and 88/2023 was started.

Due to sudden accidental death of my brother I along with my family member were broken down both mentally & physically. Because of these reasons, so we cannot lodge the complaint immediately .

Therefore I am requesting you to take necessary steps against the driver of the offending vehicle.
