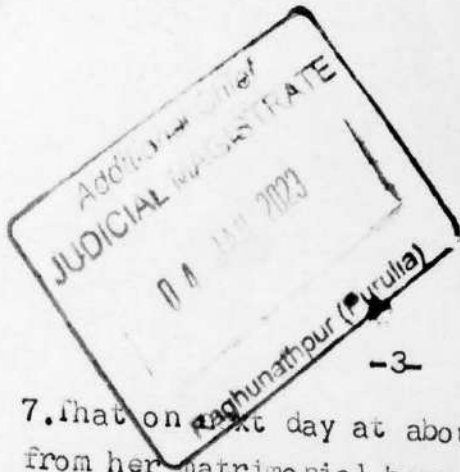

The complainant most respectfully beg to submit as follows:-

1. That the complainant is the legally married wife of the acced. no:01 Shibu Swarnakar and his address are mentioned above and their marriage was solemnised on dtd:-18-02-2022 at the house of the complainant.
2. That at the time of marriage between the complainant and the accd. person no:01, parents of the complainant given cash of RS: 1,80,000/-, 5 bhori gold ornaments, furniture, house belongings, and also gold finger ring to the acced. person.
3. That after getting their marriage, the accd. person no:-01 at the instigation and conspiracy of the other accd. persons told the complainant to bring Rs:-1,00,000/- from her father and the complainant refused to do so, whereupon the acced. person no:01 instigated by other acced. persons started torture mentally and physically upon the complainant.
4. That subsequently the complainant informed the said incident to her father and the father of the complainant given in total 40,000/- in two times for her bright future of his daughter /complainant.
5. That even then thereafter the complainant was subjected to torture constantly by the acced. persons.
6. That on 18-12-22 the complainant was assaulted and tried to murder by hanging by the acced. persons no:01 at instigation and conspiracy by the other acced. persons.

7. That on next day at about 11 A.M. the complainant was ousted from her matrimonial home and the complainant informed the said heinous incident and her father came to bring to his house at Dubra Village by Car.

8. That thereafter the complainant was taken to para Hospital for her treatment.

9. That the complainant went to Para police Station on 21-12-22 to lodge the written complaint where the concern police officer informed the complainant to take shelter of the court.

10. That finding no other alternative the complainant have to take shelter before the Ld. court for redressal of her grievances.

It is therefore prayed that your Honour may graciously be pleased to direct the ~~six~~ In-charge of Para Police Station to register the complaint to treat the same as F.I.R. against the above named accd. persons and other/others direction/directions as your Honour may deem fit and proper for the ends of justice.
