Sub-F.I.R against Pashupati Bauri, S/O-Nabin Bauri, Vill-Mahuladanga, P.O.-Bhagabandh, P.S.-Pancha, Dist-Purulia, Pin-723151 for unauthorized drawal of electricity by the way of Direct Hooking from nearest LTOH line of W.B.S.E.D.C.L at his premises.

Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that Pashupati Bauri, S/O-Nabin Bauri, Vill-Mahuladanga, P.O.-Bhagabandh, P.S.-Pancha, Dist-Purulia, Pin-723151 has committed theft of electricity under section-135 clause (1)(a) of the Electricity Act 2003 subsequently amendment Act-2007 on 08.02.2023 at about 01:30 P.M.

I Sri Saikat Mallick, S/O-Himadri Mallick, A.E & S.M of Pancha CCC along with 1) Sri Somnath Soren (J.E Gr-I) under Pancha CCC, S/O-Lt. Pannalal Soren 2) Sri Sandip Mahato (Sr.O.E.) under Pancha CCC, S/O-Lt. Brindaban Mahato, 3) Soumajit Rakshit (O.E.) under Pancha CCC, S/O-Sanjit Kumar Rakshit, 4) Sristidhar Mahato, Sr. T.S.H., S/O: Lt Ganesh Mahato, and other technical staff attached to Pancha CCC entered the premises of Pashupati Bauri, S/O-Nabin Bauri Vill-Mahuladanga, P.O.-Bhagabandh, P.S.-Pancha, Dist-Purulia, Pin-723151 a consumer of Pancha CCC having Consumer ID-200114992, Meter No-L4081422 and inspected his premises. During the inspection theft of electricity was detected by the way of Direct Hooking from nearest LTOH line of WBSEDCL under section 135 clause (1)(a) of the Electricity Act 2003 subsequently amendment Act-2007.

The accused person was consuming electricity dishonestly at his domestic premises by the way of Direct Hooking from nearest LTOH line of WBSEDCL without registering the actual consumption causing considerable revenue loss of WBSEDCL, during inspection total load was found 0.659 KVA. From the above bypassing system he uses the following electrical equipments-

- 1) Light-04 No(100 Watt Each),
- 2) Fan-02 Nos(80 Watt each)

The following items were seized from the house of the accused person-

- 1) Two core flexible wire 10(Ten) Meter approx with hooking arrangements..

Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 01:45 P.M. on 08.02.2023. The accused person has committed an offence U/S 135 clause (1)(a) of the Electricity Act 2003 subsequently amendment Act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
