Sub-F.I.R against Ramchandra Bauri,S/O-Lt. Baru Bauri,Vill-Mahuladanga,P.O.-Bhagabandh,P.S.-Puncha,Dist-Purulia,Pin-723151 for unauthorized drawal of electricity by the way of Bypassing Of Energy Meter of W.B.S.E.D.C.L at his premises.

Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that Ramchandra Bauri,S/O-Lt. Baru Bauri, Vill-Mahuladanga,P.O.-Bhagabandh,P.S.-Puncha,Dist-Purulia,Pin-723151 has committed theft of electricity under section-135 clause (1)(b) of the Electricity Act 2003 subsequently amendment Act-2007 on 08.02.2023 at about 01:48 P.M.

I Sri Saikat Mallick,S/O-Himadri Mallick,A.E & S.M of Puncha CCC along with 1)Sri Somnath Soren(J.E Gr-I)under puncha CCC ,S/O-Lt. Pannalal Soren 2)Sri Sandip Mahato(Sr.O.E.) under Puncha CCC,S/O-Lt. Brindaban Mahato,3)Soumajit Rakshit(O.E.) under Puncha CCC,S/O-Sanjit Kumar Rakshit,4)Sristidhar Mahato,Sr. T.S.H.,S/O: Lt Ganesh Mahato, and other technical staff attached to Puncha CCC entered the premises of Ramchandra Bauri,S/O-Lt. Baru Bauri Vill-Mahuladanga,P.O.-Bhagabandh,P.S.-Puncha,Dist-Purulia,Pin-723151 a consumer of Puncha CCC having Consumer ID-242013263, Meter No-DDG447455 and inspected his premises .During the inspection theft of electricity was detected by the way of Bypassing Of Energy Meterof WBSEDCL under section 135 clause (1)(b) of the Electricity Act 2003 subsequently amendment Act-2007.

The accused person was consuming electricity dishonestly at his domestic premises by the way of Bypassing Of Energy Meter of WBSEDCL without registering the actual consumption causing considerable revenue loss of WBSEDCL, during inspection total load was found 0.541 KVA. From the above bypassing system he uses the following electrical equipments-

1)Light-03 No(100 Watt Each), 2)Fan-02 Nos(80 Watt each)

The following items were seized from the house of the accused person-

1)01(one)no single phase energy meter make Genus bearing Meter No- DDG447455 with bypassing arrangements with 2core flexible wire approx 08(Eight)meter.

Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 02:10 P.M. on 08.02.2023.The accused person has committed an offence U/S 135 clause (1)(b) of the Electricity Act 2003 subsequently amendment Act-2007.You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
