Sir,

With due respect, I, Achinta Malakar, S/o- Late Kshudiram Malakar, resident of Village and P.O.-Belma, P.S – Purulia (Mfs.), District – Purulia, Pin. 723126, beg to lodge this complain against 1) Swapan Kumar Mahato, Son of Sri. Kanan Chandra Mahato, resident of Village Dubrajpur, P.O. – Pithajore, P.S – Purulia (M), District – Purulia, Pin. 723126 and 2) Tuhin Subhra Mahato, S/o- Late Dayamai Mahato, resident of Village – Lalpur, Near Mahatma Gandhi College, P.O.- Doldoli, P.S – Hura, District – Purulia, Pin – 723130 as they offered me and some of my friends to appoint me as well as my friends in the post of Primary Teacher under Government of W.B. and accordingly as per demand of said Swapan Kumar Mahato and Tuhin Subhra Mahato I along with my said friends, since the year 2017 on several occasions, compelled to hand over said accused persons total cash amount of Rs. 18,00,000/- (Rupees eighteen lakhs) for getting the job of Primary Teacher under Government W.B.

Till receiving money by said Swapan Kumar Mahato and Tuhin Subhra Mahato, in spite of repeated requests by me and my said friends; they did not take any initiative to appoint us in the Post of Primary Teacher under Government. On repeated request by me and my said friends, said Swapan Kumar Mahato and Tuhin Subhra Mahato made a written agreement with me in presence of my said friends and agreed to repay the said total amount of Rs. 18,00,000/- (Rupees eighteen lakhs). Though, I along with my friends requested them several times to repay the said amount of Rs. 18,00,000/- (Rupees eighteen lakhs), but they deferred the matter and did not take initiative to repay the same.

I have already sent them a Lawyer Notice requesting them to clear of and/ or repay the said amount of Rs. 18,00,000/- (Rupees eighteen lakhs) to me in presence of my said associates within 30 days from the date of receiving of the said notice but till now none of the said accused persons cleared off and/ or repaid the said amount of Rs. 18,00,000/- (Rupees eighteen lakhs) to me or my friends.

I therefore, request you to take suitable legal action against Samir Karmakar misdeeds and cheating so that he should be arrested and I can realise money from him and this type of activity should be stopped.
