Most respectfully begs to state:-

- 1. That accused persons named above are the relatives of the complainant and also close relative of each others.
- 2. That accused person no 3 is the husband of accused person no. 2 and the accused persons no. 4 and 5 are the children of accused no 2 and they were i.e. accused person no. 3, 4 and 5 were in judicial custody in connection with a case at Jharkhand, accordingly accused persons no. 1 and 2 instigated/ demanded from the complainant part with a sum of Rs. 3,00,000/- (Rupees Three Lakh), so that the other accused persons may be released from the judicial custody. The accused persons promised to pay the same within very short period, accordingly your petitioner by taking loans from other sources, managed and handed over a sum of Rupees 2,73,025/- (Two Lakh Seventy Three Thousand Twenty Five) to them i.e. accused person no. 1 and 2 on the promise that they will return the said amount when the accused person no 4, 5 and other persons would release from judicial custody.
- 3. That after being released of the accused persons from the judicial custody, as mentioned above, when your petitioner asked them to make payment of above mentioned loan, they denied for the same and started to abuse the petitioner with threatening, accordingly your petitioner inform the matter before Purulia(M) PS and on being interfere by the Police of Purulia(M) PS, accused person no.- 4 i.e. Rajesh Chakraborty has paid the complainant a sum of Rs. 50,000/- on a promise by accused person no. 3, 4 and 5 that the remaining balance amount i.e. Rs.- 2,23,025/- (Two Lakh Twenty Three Thousand Twenty Five) will be paid within a short period by them out of which Rs. 50,000/- will be paid within 24/01/2023, but of no good.
- 4. That on being repeated request the accused persons have refused to make the payment of the remaining balance, and abusing and threatening the complainant to face dare consequences over mobile phone.
- of 5. That the amount was given at village Bhangra, within Pundia (M)P.S. within the Junidiction of this ld. covot. of





That your petitioner has again informed the matter to the Police officers of Purulia(M) PS but they have taken no action against the accused persons over the same.

That the accused persons named above are well capable to make payment of the loan taken by them from the complainant but in order to misappropriate the money given by the petitioner, dishonestly with a common intention cheated the complainant and misappropriated the amount handed over to them by collecting from others.

That your petitioner tried to lodge a complaint against the accused person, but Police Officer of the P.S. did-not take any action against them, accordingly, the matter was informed to SP Purulia on 05/02/2023 under proper acknowledgment. The received copy of the letter given to S.P., Purulia is enclosed herewith, but no action on the part of Police, hence this petition under section 156(3) CrPC to send the same to the officer in charge purulia(M) PS, treating the same as an FIR for unearth the wrongdoer and realization the misappropriated amount, so that the accused may be booked and faced the trial in the Court of Law for the ends of justice.

It is therefore prayed that your Honour will be graciously pleased to send this petition to the I/C of Purulia(M) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr.P.C. and to investigate the case in accordance with law and to unearth the wrongdoer and realization the misappropriated amount, so that the accused may be booked and faced the trial in the Court of Law.
