Subject:- FIR against Majua Khatun, Daughter of Lt Nishar Quraishi, resident of Taldanga, Poultry farm road, Purulia Town Police Station, Dist Purulia.

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/b, 1/d & 1/e of the electricity Act 2003, Amendment of 2007 as stated here under.

On 08/02/2023 at 11.24 Hrs. I, Sri Subhajit Pratihar AE & SM Purulia CCC WBSEDCL along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL), Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) and ASI Nayan Chandra Mondal along with other two officials from Purulia Town PS (as per earlier requisition) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises (of Majua Khatun, Daughter of Lt Nishar Quraishi, resident of Taldanga, Poultry farm road, under Purulia Town Police Station, Dist Purulia. In spite of several telephonic communications the consumer did not come to the premises therefore undersigned along with the team entered the premises at 11.35 hrs.

During the time of inspection at the premises 1 nos of electricity meter was found having serial no GE0042045 (Consumer id 202798042, Consumer Name-Majua Khatun).

In presence of Police personnel's it was observed that consumer Majua Khatun has made unauthorized use of electricity under section 135 1/b, 1/d & 1/e by inserting foreign material in meter serial no GE0042045, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Toto charger 5 nos (400 watt each), Light 2 nos (9 watt each) in her commercial premises.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service line in the premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter no GE0042045.

The inspection team left the premises at about 12.05 Hrs on 08th Feb 2023.

The accused committed theft of electricity U/S 135 1/b, 1/d & 1/e of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
