I Ashok Kumar Budhia, S/o Lt. Thakurdas Budhia resident of Nilkuthi Danga, ward-10, Purulia and sole proprietor of the firm Ashok Trading Company, Telkal para, Purulia.

On 13.02.2023 at about 10:00 AM while calculating our stocks, we came to know that 50 Mustard oil (BULAND) tins and 20 palmoline oil tins went missing from our respected godown. We suspected all these missing goods were being theft.

We doubted that the person behind this mishappening incident is one of our previously worked daily waged worker namely Rakesh Nandi, S/o Lt. Ramesh Nandi a resident of Mohulghata, ward-11, At presently living at Rajaland, Bhuiya para, Purulia. He had worked at our firm during the month of December year 2022 for just about 5 days but was dismissed from the work because of his bad attitude. We also suspect that there are more people related to him in this incident.

So, I hereby request you to take all the necessary lawful actions in this misfortunate incident.
