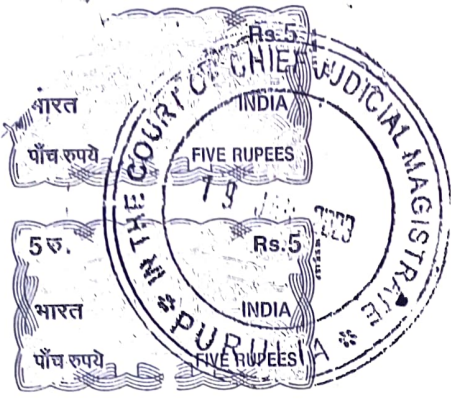

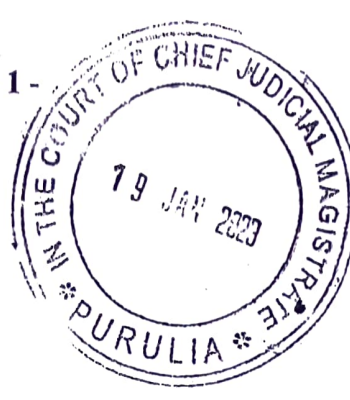

Most respectfully begs to state:-

1. That the complainant, Aslam Parvez, S/o- Late Mohibuddin, and Samshed Alam, S/o- Late. Md. Israil, a resident of Islamnagar, Chunabhatti, Near Water Tank, Purulia Municipal Ward No. 22, P.O- Purulia, P.S- Purulia (T), Dist- Purulia, i.e the accused person No.1, used to deal a partnership business without executing any partnership deed, since last few years, from a shop situated at Super Market, under the name and style as "Maria Footware", Room No. B-11, Ground Floor, Hat tola More, Purulia.
2. That in the recent past i.e in the month of October, 2022, said Samshed Alam i.e accused No. 1, placed the accounts and disclosed that he will give the other two partners to their respective share and out of the share of the

complainant, he gave the complainant a cash of Rs. 10,00,000/- on 10.10.2022 and promise me to pay the balance amount on 25.10.2022.

3. That on the said date i.e on 25.10.2022, Samshed Alam called the complainant to Maria Footware, and when he reached there along with his brother namely Mojammil Hussain, at about 2:30 P.M, the complainant and his brother noticed that Md. Iqbal, S/o- Abdul Barik, a resident of Rani Bandh, Near Khan Khatal, Purulia Municipal Ward No. 9, P.O- Purulia, P.S- Purulia (T) and Dist- Purulia and Md. Inamuddin, S/o- Md. Nizamuddin, a resident of Kasai Mohalla, Near Qurraishi Mohalla Masjid, Purulia Municipal ward No. 10, P.O- Purulia, P.S- Purulia (T), Dist- Purulia, i.e the accused persons No. 2 and 3 were present at the shop. At that time said Samshed Alam gave the complainant a sum of Rs. 5,00,000/- and on demand of the rest amount he refused to give any further sum. On protest made by the complainant, the accused 'No. 1 suddenly became violent and Samshed Alam, Md. Iqbal and Md. Inamuddin i.e all the accused persons started to assault the complainant and his brother in a brutal manner, Samshed Alam hit on the chest of the brother of the complainant namely Mojammil Hussain, by using iron punch and other two accused persons assaulted the complainant and his brother by lathi on their hand. All the accused persons snatched the said amount and Samshed Alam pressed the neck of the complainant in order to strangle him.
4. That under the circumstances it is clear that Samshed Alam with intend to deceive the complainant, entered into the partnership business, misappropriated the amount of the business, committed criminal breach of trust and cheating and in order to hush up the money, assaulted the complainant and his brother in a pre-planned manner in connivance with Md Iqbal and Md. Inamuddin, causing wrongful loss to the complainant and wrongful gain to himself and assaulted the complainant and his brother by using iron punch and wooden stick, pressed the neck of the complainant in order to kill him and thereby committed various offences which are punishable as per law.

- 5. That after treatment, the complainant had been to the Purulia (T) P.S in order to lodge a complaint, but the duty officer refused to accept the same, accordingly the complainant posted the complaint through registered post on 20.12.2022, but after receiving the same no action has been taken by the police station.

- 6. That subsequently, the Complainant on 28.12.2022 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to Inspector-in-charge of Purulia (T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
