I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/a of the electricity Act 2003, Amendment of 2007 as stated here under.

On 23/02/2023 at 15.43 Hrs. I, Sri Subhajit Pratihar , A.E & Station Manager , Purulia Customer Care Centre (CCC) along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL) , Chinmay Maity (JE Purulia CCC) , Anurag Pandey (OE Purulia CCC) , Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for domestic purpose at the domestic premises of Chamu Khan, Son of Rejjak Khan, resident of Chuna Bhati , JK College Road , Purulia (T) PS, Dist Purulia .

It was observed that accused Chamu Khan has made unauthorized use of electricity under section 135 1/a by direct hooking from our nearest LTOH line through a 2 core pvc cable of length 12 feet approx, connected to a wooden make switch board. From the above arrangement the accused was using Fan 2 nos (80 watt each), Light 2 nos (40 watt each), Toto charger 1 nos 400 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the hooking arrangement from pole with the help of LT Mobile Van Team and removed & seized the hooking arrangement along with the wooden make switch board.

The inspection team left the premises at about 16:10 Hrs on 23rd Feb 2023.

The accused committed theft of electricity U/S 135 1/a of the electricity Act 2003, Amendment of 2007.
