Sir,

In producing herewith the arrested accused persons namely (1) Jalil Ansary (40) S/o Sariful Ansary of Vill.- Swetpalash, PO – Cheliama, PS – Raghunathpur, Dist.- Purulia, (2) Amjed Ansary (24) S/o Alauddin Ansary of Vill.- Paranpur, PO – Rukni, PS – Raghunathpur, Dist.- Purulia, (3) Akbar Ansary (28) S/o Lt. Ibrahim Ansary of Do and (4) Muksed Ansary (28) S/o Jafar Ansary of Do and seized 04 (Four) Nos. of Motorcycles loaded with approx 12 Qntls. Steam Coal. Fact of the case in brief is that on 31.01.2023 myself along with C/600 Amit Shit, NVF/696 Sibaprasad Singh Sardar both of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 288/23. On 01.02.23 at about 04:15 hrs. received a credible source information that the above noted Motorcycles loaded with coal were assembled and coming from Kargali side towards Rukni side. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Dhanara village more and parked the vehicle from a distance. Then we have cordoned the place by our police personnel and found that some persons having loaded coal with Motorcycles were coming, at that time we were able to apprehend 04 (Four) Nos. of Motorcycles vide (1) Red colour Hero Honda Splendor bearing Reg. No. WB 12K/2338, (2) Red black colour Hero Passion Pro bearing Reg. No. JH 10AL/2457, (3) Red colour Hero Honda CD Dawn bearing Reg. No. JH 10C/9432 and (4) Black colour Hero Honda CD Dawn bearing Chasis No. 04F27F25379 with loaded coal and its riders. On asking the riders of the said Motorcycles failed to produce any papers in respect of said loaded Coal as well as papers in respect of those Motorcycles. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those Motorcycles collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation they confessed their guilt. As such it is every reason to believe that those persons along with Motorcycles are transporting the said coal illegally. As such I seized those Motorcycles loaded with Coal under proper seizure list duly signed by the accused persons and witnesses. I also arrested of those persons after observing all formalities and narrating their ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each motorcycle collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Jalil Ansary (40) S/o Sariful Ansary of Vill.- Swetpalash, PO – Cheliamma, PS – Raghunathpur, Dist.- Purulia, (2) Amjed Ansary (24) S/o Alauddin Ansary of Vill.- Paranjpur, PO – Rukni, PS – Raghunathpur, Dist.- Purulia, (3) Akbar Ansary (28) S/o Lt. Ibrahim Ansary of Do and (4) Muksed Ansary (28) S/o Jafar Ansary of Do as per law and arrange for its investigation.
