Sir,

In producing here with one tractor bearing registration No-WB 55A/1406 including trolley loaded with approx 02 MT steam coal under proper seizure list, on 21.02.2023 Myself along with C/207 Dilip Kr Paul and NVF/696 Shib Prasad Singh Sardar were performing evening mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 499/23. On 21.02.23 at about 19:45 hrs. received a credible source information that the above noted tractor including trolley loaded with steam coal is coming from Sankra village side towards Chinpina village. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction on 21.02.23 at about 20.15 hrs. we reached near at Chinpina Rail Gate and parked the vehicle from a distance. Then we have cordoned the place by our police personnel and found that one tractor was coming, on seeing the Police Party from a distance the miscreants fled away from the spot leaving the tractor bearing registration No. WB 55A/1406 and could manage to escape despite our all efforts. On verification we found the said tractor including trolley has loaded with approx 02 MT steam coal.

On secret enquiry through my reliable source it came out that the owner of the tractor with his full knowledge and consent sent this tractor along with his driver for loading coal illegally for clandestine business and procuring the Coal by theft or any dishonest means from illegal mines/pits with a view to dispose off the same by transporting the Coal for their wrongful gain.


So, I seized the tractor bearing Regd. No. WB 55A/1406 including trolley loaded with approx 02 MT steam coal after preparing a proper seizure list duly signed by my accompanying forces and brought to PS. No public witnesses were turned up there. Approx 01 (One) K.G. Coal seized from the said tractor including trolley loaded with steam coal as sample coal.

I therefore pray before you, kindly lodge an FIR against the owner, driver of the tractor bearing Regd. No-WB 55A/1406 under proper section of law and also arranging for its investigation.
