Sir,

In producing herewith the arrested accused person namely Sambhu Tantubai (58) S/o Lt. Bhajahari Tantubai of Vill.- Sanka, PS - Raghunathpur, Dist.- Purulia and seized (1) One Vespa Scooter without number plate loaded with approx 05 (Five) Qntls. Coal in plastic bags, (2) One Vespa Scooter without number plate loaded with approx 05 (Five) Qntls. Coal in plastic bags, (3) One Vespa Scooter without number plate loaded with approx 05 (Five) Ontls. Coal in plastic bags, (4) One Bajaj Kawasaki 4S motorcycle without number plate loaded with approx 05 (Five) Qntls. coal in plastic bags, (5) One TVS XL moped bearing Reg. No. WB 82C/1938 loaded with approx 1 ½ (One & Half) Qntls. coal in plastic bag, (6) One TVS 4S moped bearing Reg. No. WB 82F/0044 loaded with approx 1 ½ (One & Half) Ontls. coal in plastic bags and (7) Two (02) Ontls. approx coal in the courtyard of Sambhu Tantubai S/o Lt. Bhajahari Tantubai. Fact of the case in brief is that on 23.02.2023 myself along with C/737 Haradhan Nayek and NVF/1089 Swapan Paramanik both of Raghunathpur PS were performing night mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 530/23. On 23.02.23 at about 05:25 hrs. received a credible source information that one person namely Sambhu Tantubai is stocking coal from the loaded motorcycle by fraudulent means at his courtyard at Ragerdih Para, near Shiv Mandir under Sanka village. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached at Ragerdih Para, near Shiv Mandir under Sanka village and held raid at there. During raid we found six numbers of motorcycles loaded with coal were standing at that PO, some coal was stocked there and we able to apprehend one Sambhu Tantubai and six drivers were manage to escape there. On asking the said Sambhu Tantubai failed to produce any papers in respect of said loaded Coal as well as papers in respect of those motorcycles. He also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the said Sambhu Tantubai and motorcycles riders of those 06 (Six) Nos. of Motorcycles collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation he confessed his guilt and disclosed the name of 02 (two) riders as Manoj Bauri and Fatik Bauri both of Kargali village, PS - Raghunathpur. As such it is every reason to believe that those persons along with motorcycles riders are transporting the said coal illegally. As such I

motorcycles loaded with coal including stocked coal under proper seizure list duly signed by the accused person and witnesses. I also arrested of the above noted person after observing all formalities and narrating their ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each vehicle and one KG from courtyard seized as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused person namely (1) Sambhu Tantubai (58) S/o Lt. Bhajahari Tantubai of Vill.- Sanka, PS – Raghunathpur, Dist.- Purulia, (2) Manoj Bauri of Kargali village, PS – Raghunathpur, Dist.- Purulia, (3) Fatik Bauri of Do and others as per law and arrange for its investigation.
