Sir,

In producing herewith the arrested accused persons namely (1) Bablu Sadhu (39) S/o Rathin Sadhu of Vill.- Achkoda, PS – Neturia, Dist.- Purulia, (2) Habu Sadhu (42) S/o Lt. Amulya Sadhu of Do and (3) Aditya Sadhu (50) S/o Haripada Sadhu of Do and seized 07 (Seven) Nos. of two wheelers loaded with approx 1 Qntls. Coal each. Fact of the case in brief is that on 10.02.2023 myself along with C/185 Rajesh Roy and C/207 Dilip Kr Paul both of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 383/23. On 11.02.23 at about 05:15 hrs. received a credible source information that the above noted two wheelers loaded with coal were assembled and coming from Kargali side. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached at Kargali near Durga Mandir on Kargali – Cheliyama Road and waiting there. Then we have cordoned the place by our police personnel and found that some persons having loaded coal were coming, at that time we were able to apprehend 07 (Seven) Nos. of two wheelers vide (1) One TVS XL 100 motor cycle bearing Reg. No. WB 82E/1679 loaded with approx 1 Qntl. Coal in plastic bag, (2) One Scooter bearing Reg. No. WB 56/8227 loaded with approx 1 Qntl. Coal in plastic bag, (3) One TVS XL 100 motorcycle bearing Reg. No. JH 10BV/7794 loaded with approx 1 Qntl. Coal in plastic bag (4) One Vespa scooter without Registration No loaded with approx 1 Qntl. Coal in plastic bag, (5) One Vespa scooter without Registration No loaded with approx 1 Qntl. Coal in plastic bag and (6) One Vespa scooter without Registration No loaded with approx 1 Qntl. Coal in plastic bag and (7) One TVS XL 100 motorcycle without Registration No loaded with approx 1 Qntl. Coal in plastic bag and 03 (three) riders as noted above and 04 (four) riders have been fled away. On asking the riders of the said two wheelers failed to produce any papers in respect of said loaded Coal as well as papers in respect of those two wheelers. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those two wheelers collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation they confessed their guilt. As such it is every reason to believe that those persons along with two wheelers are transporting the said coal illegally. As such I seized those two wheelers loaded with Coal under

proper seizure list duly signed by the accused persons and witnesses. I also arrested of those persons after observing all formalities and narrating their ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each two wheelers collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Bablu Sadhu (39) S/o Rathin Sadhu of Vill.- Achkoda, PS – Neturia, Dist.- Purulia, (2) Habu Sadhu (42) S/o Lt. Amulya Sadhu of Do, (3) Aditya Sadhu (50) S/o Haripada Sadhu of Do and 04 (Four) unknown others riders of the seized two wheelers as per law and arrange for its investigation.
