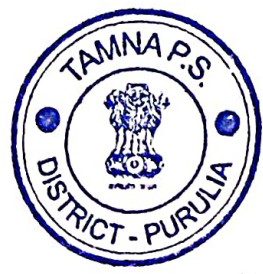

Sir,

In producing herewith arrested offending driver namely Bajrang Digar (24 Yrs), S/O- Baru Digar of Vill + P.O- Kantadih, PS- Arsha, Dist- Purulia along with one seized White Colour ACE MEGA XL bearing Registration No. WB55A/8963.

I, Surajit Kr. Das S/O- Samir Kr. Das of Vill- Kalipur Majhpara, P.O- Karidhya, PS- Suri, Dist- Birbhum at present posted at Tamna PS, Dist- Purulia as SI of Police beg to report that today myself along with HG/1861 Dipak Kumar and HG/1747 Ajit Hembram all of Tamna PS were performing anti-crime day mobile duty under Tamna PS area vide Tamna PS GDE No. 171 Dtd- 04.02.2023 at about 15:45 hrs. found one White Colour ACE Van bearing Registration No. WB55A/8963 loaded with straw as unsafe condition was coming from Balarampur side and going towards Purulia side rashly and negligently along with unsafe condition of loaded straw. We tried to stop the said vehicle but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop the said vehicle on Purulia-Tata (NH-32) pitch road near Simulia Smashan Kali Mandir under Tamna PS, Dist- Purulia. On being asked, he stated his identity as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person under proper memo of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC & 190(iii) MV Act. I also seized the White Colour ACE MEGA XL bearing Registration No. WB55A/8963 loaded with straw in presence of witnesses and informed him and his relatives regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Bajrang Digar (24 Yrs), S/O- Baru Digar of Vill + P.O- Kantadih, PS- Arsha, Dist- Purulia.
