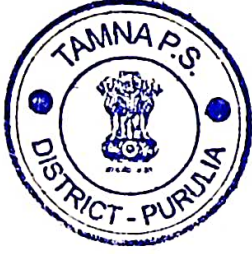


In producing herewith the arrested accused person namely Dasarath Mahato (42 Yrs) S/o- Nabaghan Mahato of Vill- Kourang, PS- Arsha, Dist- Purulia along with seized articles, to the effect that on 03.02.2023 at about 05:15 hrs received a credible information that some persons were shorting the iron chips from their go-down beside Deben Mahato Line Hotel at Karamara under Tamna P.S. this matter informed my O/C, Tamna P.S. as per his direction myself along with C/-572 Lakshikanta Sinha, NVF/635 Dhiren Daw of Tamna P.S vide CC No-367/23, Dtd.02.02.2023 & Tamna PS GDE No. 80 dtd. 02.02.2023 immediately reached at near Deben Mahato Line Hotel at Karamara under Tamna P.S and found that 05-06 persons were staging iron chips and iron plate at front of the godown near Deben Mahato Line Hotel at Karamara under Tamna PS. Seeing the Police party they tried to flee away, but we apprehended the above noted person after hot chase. On interrogation he disclosed his identity as mentioned above. He stated that one Vicky Jain is the owner of the godown. I asked him to call Vicky Jain but no one come since long time and also asked him to produced valid documents in respect of staged articles. He failed to produced any valid documents. So, there is every reason to belief that the owner and others are dealing this business in clandestine manner. So I arrested Dasarath Mahato (42 Yrs) S/o- Nabaghan Mahato of Vill- Kourang, PS- Arsha, Dist- Purulia after issuing memo of arrest and observing legal formalities of arrest and seized 1) Spong guli - 210 bags per bag approx 50 kg, 2) Red Sponge Chips - 45 bags per bag approx 50 kg, 3) Iron Bar - 23 pcs per pic approx. 10 kg, 4) Iron Rod @ 08 mm - 12 pcs, 5) Iron Rod @ 20 mm - 01 pc, 6) Iron Plate – 02 pcs per piece approx. 70 Kg. & 7) Computerized/Electronics weight machine- 02 pcs. After completion of all process, myself along with force brought arrested accd persons and Seized articles.

Therefore, I do hereby lodge this complaint against the above noted arrested accd person and owner of the go-down who fled away, hence they have committed theft, purchase and dealing stolen property.
