In producing here with one arrested accused namely Binod Shaw (52 Yrs) S/O Lt. Kaltu Shaw of near DVC Adra irani Para, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 09 (Nine) bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.
- 2) 08 (Eight) bottles DIL KHUSH country spirit, 300 Ml. each Rs/-25 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample
- 3) Sale proceed of Rs- 55/-

I SI Simanta Tantubai of Adra PS do here by lodged a complaint against accused namely Binod Shaw (52 Yrs) S/O Lt. Kaltu Shaw of near DVC Adra irani Para, PS-Adra, Dist- Purulia to the effect that on 18/03/2023 at about 17:05 hrs I received a information from a reliable source that one Binod Shaw has been stock of country spirit illegally at his old tea stall at Adra Market near Muktadal Club. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-811/23 dtd.18.03.2023. I reached at Adra Market near Muktadal Club at about 17:25 hrs and hold raid in the old tea stall at Adra Market near Muktadal Club of said Binod Shaw and found that the said person selling liquor at his old tea stall at Adra Market near Muktadal Club and after seeing the Police party some person fled away and said Binod Shaw has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Binod Shaw selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 17.25 hrs to 18.05 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Binod Shaw (52 Yrs) S/O Lt. Kaltu Shaw of near DVC Adra irani Para, PS-Adra,
